Strengths – Full page detailed resumes of key personnel; Calibrated machines every Monday. Commitment to SBE/SDV Participation and efforts to ensure prompt payment as submitted in the SBE/SDV Plan.

Weaknesses – Overall proposal was difficult to read. Qualifications and experience not of similar complexity since the proposal failed to demonstrate experience with government entities or the capacity to handle the scope of services. Proposal failed to demonstrate experience and qualifications of proposed subcontractors. Delivery proposal demonstrated a lack of understanding of scope of services and the volume of Metro's needs. Proposed transition plan lacked detail. Sustainability plan lacked detail. Small and/or Service Disabled Veteran-owned Business Plan lacked details regarding strategic approach. Small and/or Service Disabled Veteran-owned Business Plan failed to include monitoring/reporting information.

Ricoh USA

Strengths – Strong Qualifications and Experience Proposal submitted that clearly shows the ability to perform the scope of service. Strongly proposed transition plan and detailed sustainability plan. Commitment to SBE/SDV Participation and monitoring and reporting as submitted in the SBE/SDV Plan.

Weaknesses – Failed to provide full resumes of key personnel. Proposal demonstrated limited owned or leased equipment that will be readily available for devotion to scope of service and associated requirements as compared to other Offerors. Small and/or Service Disabled Veteran-owned Business Plan lacked details regarding strategic approach and efforts to ensure prompt payments.

RJ Young

Strengths – Strong Qualifications and Experience Proposal that clearly shows the ability to perform the scope of service. Proposal included a detailed graphic services process including "rounds of revision (as may be deemed necessary by client)". Ready availability of equipment, staff, and supplies demonstrated within the proposal. Strongly proposed transition plan submitted.

Failed to submit a Small and/or Service Disabled Veteran-owned Business Plan detailing the strategic approaches taken to include Small and/or Service Disabled Veteran-owned Businesses.
