Strengths: Firm provided a detailed demonstration of their knowledge in Workforce Development, specifically in providing training in the area of CompTIA A+ certification. Firm provided a detailed description of why they are best suited for the project. Firm provided detailed experiences of projects of similar size and scope. Firm provided a detailed description of lessons learned in conducting hands on visual training in CompTIA A+ certification. Firm provided detailed strategies and services that would be used to meet the objectives of the CompTIA A+ certification program. Firm provided a detailed description of how they will support the participants that may have barriers in obtaining the CompTIA A+ certification. Firm provided a detailed list of strategies that would be used to support the participants. Firm provided a detailed description of their experience in hardware and software regarding CompTIA A+ certification training.

Weaknesses: Firm's outline demonstrating their approach to providing CompTIA A+ certification training and employment opportunities over the last five years lacked specific details. Firm provided an example of training experience associated with aviation (the aviation training is based on the A+ principles), but did not provide an example of training experience associated with CompTIA A+ certification.

Lab Four Career Training Institute 57.40 Points

Strength: Firm provided detailed reference projects of similar size, scope, and complexity.

Weaknesses: Firm's organizational structure lacked specific details. Firm's demonstration of relevant experience lacked specific details. Firm's description of why they are best suited for the project lacked specific details. Firm's experience of projects of similar size and scope lacked specific details. Firm's demonstration of knowledge of the project objectives/goals lacked specific details. Firm's demonstration of efficient use of team members, material resources, equipment, and technology necessary lacked specific details. Firm's strategies to meet the training objectives for participants to obtain CompTIA A+ certification lacked specific details. Firm's outline of classroom instructions lacked specific details. Firm listed their program as an eight week program, but the scope of work requires a 12 week program.

Continuation of Strengths & Weaknesses for RFQ# 1043683 Comp TIA Training and Certification

More Computing Learning Services 80.00 Points

Strength: Firm provided a detailed outline demonstrating their approach to providing CompTIA A+ certification training and employment. Firm provided detailed reference projects of similar size and scope.

Weaknesses: Four of the six required CompTIA A+ technology training opportunities detailing the firm's experience within the last three years lacked specific details. Firm's demonstration of how the requirements and provisions of the scope of work will be implemented lacked specific details. Firm's demonstration of knowledge of the project objectives/goals lacked specific details. Firm's strategies to meet the training objectives for participants to obtain CompTIA A+ certification lacked specific details. Firm's availability of soft skills training lacked specific details. Firm's reference projects of similar complexity lacked specific details.
