## **Bird Rides Inc**

**Strength** – Proposal demonstrated in-depth experience of projects of similar size, scope, and complexity. Proposal included a 30-minute response time for ADA reported issues and an hour response time for other reported issues. Proposal included 2 full time employees for 100 scooters. Proposal included a financial impact approach for riders to encourage good user behavior for use of a scooter. Diversity practices indicated the organization is moving in the right direction to making supplier diversity a priority.

**Weaknesses** – Proposal for approach included the need for sensor stations in order to implement GPS accuracy. Proposal approach for e-bikes lacked detailed. Diversity practices demonstrated a lack of tracking diverse business spent and did not include any estimate of what may be spent.

### **Blue Duck Scooters**

**Strength** – Proposal demonstrated that there was no violation included as part of their performance on past projects.

**Weaknesses** – Proposal demonstrated experience in smaller market and for a shorter timeframe compared to other offerors. Proposal disclosed personal injury lawsuit and business bankruptcy. Proposed approach does not allow riders to carry any bags and has a weight capacity limit that would limit ridership. Proposal demonstrated a 2-hour response time. Proposal lacked detail in the approach to fines compared to other offerors; Proposal demonstrated a lack of understanding of regulations related to shared urban mobility devices within the approach; Proposal demonstrated that education only would be used for enforcement. Diversity practices did list a employee leading their supplier diversity initiatives, but failed to demonstrate practices or what is being work on related to supplier diversity practices.

# **Bolt Mobility Tennessee LLC**

**Strength** – Proposal demonstrated the use of full-time employees and not contractors; Proposed approach for e-bikes was unique and extremely detailed.

**Weaknesses** – Proposal for qualification and experience provided vague responses; Proposal failed to demonstrate a response to the disciplinary actions. Proposal demonstrated a 2-hour response time and clarification demonstrated a 30-minute ADA response time. Overall proposal included numerous "cut and

paste" responses and lacked proofreading. Even in clarification never really clearly answered question about accuracy of geolocation of their devices and sidewalk detection. Diversity practices failed to demonstrate supplier diversity practices due to the company being newer.

# **Lynx City LLC**

**Strength** – Proposal demonstrated a 30-minute response time for ADA reported issues; Proposal demonstrated the use of helmets for riders.

Weaknesses – Proposal demonstrated extremely smaller size experience. Proposal only include two individual as proposed team and key personnel. Proposal failed to provide an organizational chart. Proposal lacked information related to past partnership experience. Proposal failed to respond to any risk/obstacles that took place in past partnerships. Proposal failed to include an operation plan as requested in the evaluation criteria, including information related to addressing ADA complaints/issues. Proposal demonstrated that no ID check would be used to verify age of rider. Proposed approach was educational focused. Overall proposal for Qualifications & Experience along with Approach lacked detail compared to other offerors. Diversity practices failed to identify an individual tasked with supplier diversity initiatives. Diversity practices demonstrated that there is no prior fiscal year data and not participating in a government approved minority mentor program.

# Neutron Holdings, Inc. dba Lime

**Strength** – Proposal demonstrated in-depth experience of projects of similar size, scope, and complexity. Proposal demonstrated a unique technology approach; Proposal demonstrated a detailed approach to ebikes approach with the use of a deployment matrix. Proposal demonstrated the use of quizzes for riders at the beginning to assist with ensuring that users know the rules. Proposal demonstrated a very detailed sustainability approach. Proposal demonstrated the use of scooters that will sense whether it is operational on the road or on the sidewalk. Proposal demonstrated the use of ID scan for rider to activate scooter. Proposal demonstrated the use of LCD screen immediate communication. Proposal demonstrated the use of a fine schedule for poor using behavior. Proposal has a detailed approach on

equity issues. Diversity practices demonstrated evidence that supplier diversity is part of their business practices.

Weaknesses – Proposal included drunk screen quiz showing certain hours that does not align with required times outlined in the regulations. Proposal included screen shots of technology that instructs riders that it is acceptable to ride on sidewalks if road conditions are unsafe which is also against regulations. Proposal included illustrations that implies it is acceptable to drink and ride by stating "drinking and riding is often illegal"). Proposed approach states rebalance of parked scooters to avoid overcrowding "on Broadway" which would violate the regulations since no parking on Broadway is allow per the regulations. Proposal included illustration of a sandwich board placed on the sidewalk bearing a legend encouraging riders not to ride on the sidewalk; however, Metro Code and rules do not allow sandwich boards to be placed on sidewalks. Proposed a 2-hour response time for ADA reported issues. Proposal demonstrated a 2-hour response time for general issues. Failed to provide a response to the clarification question by the established deadline.

## **Skinny Labs Inc.**

**Strength** – Proposal demonstrated in-depth experience of projects of similar size, scope, and complexity. Proposal demonstrated the use of a fine schedule for poor using behavior. Proposed an average of 30-minute response time for ADA reported.

**Weaknesses** – Proposed approach was educational focused. Overall proposal for Qualifications & Experience along with Approach lacked detail compared to other offerors. Diversity practices only mentioned diversity committee for recruiting and does not mention anything related to supplier diversity.

## Superpedestrian, Inc.

**Strength** – Proposal demonstrated extensive experience performing the scope of services in medium market size. Proposal demonstrated smart city experience. Proposed detailed approach reflected how they stood out compared to their competitors. Proposed technology focused approach as it relates to on board mapping and recognition of on-board riding is within seconds. Provided impressive supplier diversity work given the company is relatively new that demonstrated genuine commitment to supplier diversity.

**Weaknesses** – Proposal failed to demonstrate how offeror would verify if rider was at least 18 years old. Proposal failed to demonstrate an e-bike option in accordance with the state definition of e-bikes. Proposal provided a 2-hour response time for ADA related reported issues.

#### **VeoRide Inc**

**Strength** – Proposal demonstrated Integration experience. Proposal demonstrated geofencing capabilities.

**Weaknesses** – Proposal lacked experience of similar size. Proposal demonstrated a traditional space geofencing approach with 10-foot accuracy. Proposal provided a 2-hour response time for ADA related reported issues along with other reported complaints. Proposed approach lacked detail compared to other offerors. Failed to provide response to diversity practices by solicitation deadline.

#### Wheels Labs, Inc.

**Strength** – Proposal demonstrated helmet integration into the process. Proposed approach was very unique compared to other offerors. Proposal demonstrated that offeror had a large volume of scooters. Proposed approach provided parking and riding classes for education but if not successful then rider would be banned; Proposed approach required ID scanning of riders.

**Weaknesses** – Submitted proposal was a copy and paste of other responses throughout proposal. Proposal failed to demonstrate who will be available to address issues reported. Proposal failed to provide a fine schedule. Proposal failed to demonstrate an e-bike option in accordance with the state definition of e-bikes. Diversity Practices lacked documentation to support the responses provided.
