No firm date just ranges on delivery time form. Proposer failed to meet several specifications listed in Minimum Specifications form required by Metro. Some key aspects such as section 3.8.1, 3.3.22, 3.3.8, 4.1.2, 4.1.3, etc, responded with "NO".

Met government and ten year experience on Delivery Time Form.

## Weaknesses

Proposer responded with "NO" on key aspects; Sections 3.3.1, 3.3.15, 3.3.26, 3.3.28, 3.4.8. On Proprietary Parts, parts are made by a 3rd party which all parts related are now renamed and renumbered as REV parts which has created proprietary parts issues. Construction date was one of the highest on the Delivery Time Form.

## Strengths

Met all minimum specifications requested. Gave a date not range on the delivery time form and met all experience requirements on the delivery time form.

#### Weaknesses

Proposal was not clear on Training days listed.

Toyne Inc

Strengths

Met most specifications. Met the experience requirement on the Delivery Time Form. Weaknesses

Longest construction time on the Delivery Time Form and gave a date range not a specific date listed. On Proprietary Parts, parts are made by a 3rd party which all parts related are now renamed and renumbered as REV parts which has created proprietary parts issues. On section 3.3 the response was "yes" however the cab manufacturuer states they use "bonding" in the building of the cab.
