No specific detail regarding the Management Approach for the Berry or Richland Head Start playgrounds. Project schedule not specific towards the Berry and Richland Head Start playground areas and specified timeframe within the scope of work.

## First Place Finish, Inc.

Strengths - Design concept fitting for Early Head Start age range. Detailed breakdown of project schedule.

Weaknesses - Project references not representative of similar age group. Failed to provide a resume or CV of Project Manager.

#### **Great Southern Recreation**

Strengths - Great qualifications with Project Manager certifications. Natural grass area included in design concept. Included detail about 6 feet fall zone. Contingencies addressed within project schedule.

Weaknesses - Project references not representative of similar age group. Weak depiction of design concept structures.

### Korkat, Inc.

Strengths - Fence in design concept.

Weaknesses - Unclear experience and qualifications as it relates to the Early Head Start age range. Failed to provide a resume or CV of Project Manager. No dedicated area for wheeled toys in design concept at Berry Head Start. Weak design concept with rubber mulch at Berry Head Start.
