Strengths -

Former member of Tennessee General Assembly and on Local Government Committee, Former member of Davidson County delegation. No conflicts of interest. Excellent busingess approach and risk mitigation provided. The strong relationships with key Democrats and with the Davidson County Delegation would serve Metro well.

Weaknesses -

Capacity questioned because not very many staff available. A single but well qualified staff member.

Schmidt Government Solutions, LLC

Strengths -

Years of experience. Worked closely with Housing issues. Good conflict of interest information. Proactive approach is detailed, doesn't like surpreises. Education and dealing with Davidson County legislation. Ability to draft amendments for Metro. Keeping Davidson County legislation informed. Would testify if needed. Can supply as many as 8 staff to help in lobbying. Strong Republican relationships and lead lobyist would serve Metro Well.

Weaknesses -

Formatting and contact information not in compliance with RFP requirements. Haven't faced difficult lobbying efforts with current clients. Voiced difficulty with dealing with particular legistlator. Didn't discuss with minority leader bills effectiing them. Dates for achieving accomplishments not shown. Not much experience with lobbying local government issues at the General Assemly.

New Horizon Solutions

Strengths -

Approach to using Nashville themes in receptions. Willing to testify. Passioonate about issues.

Weaknesses -

No current experience. No client list. Limited to healthcare and judicial. Work in conflict with big Metro health issue. Will depend on Metro Legal when amendment needed. Only relationships mentioned are with former members. No knowledge of areas of concern for Metro. Only person available and will have to subcontract in her absence. No risk mitigation plan.

Windrows Phillips Group

Strengths -

Excellent expeirence in working with Metro. No conflicts of interest with client list. Four dedicated staff. Understanding of how the Tennessee General Assembly process works. Strong evidence of oversight and reporting.

Weaknesses -

Proactive approach not in line with Metro needs. More reactive as apposed to proactive. Underappreciation for Metro involvement. Relationship with Davidson County Legislation. Little evidence that they would draft proposed legislation for Metro review.
