Strengths -

**Qualifications and Experience:** Training program well thought out; number of plumbers qualified to work on backflow preventers

**Service Delivery:** In-house 24/7 phone access for service calls

### Weaknesses -

**Qualifications and Experience:** Failed to list an exact number of employees; detail regarding experience with other arrangements similar in size, scope, and complexity was limited; Section 3.3 did not describe their resources; Section 3.4 did not address plumbing issues

**Service Delivery:** Lacked detail on how they would meet Metro's proposed schedules; did not explain how service calls are dispatched; no clear detail of the number of service technicians they have available

## S.M. Lawrence Company, Inc.

#### Strengths -

**Qualifications and Experience:** Section 3.2 provided strong detail on experience and listed multiple examples of other businesses served

**Service Delivery:** Provided detail on how they would go about giving Metro priority over other work; number of plumbers that met Metro's security background check; stated company can exceed Metro's required timeframes

### Weaknesses -

**Qualifications and Experience:** Section 3.2 experience was not all related to plumbing; Section 3.3 did not describe their resources; training program not as detailed

Service Delivery: Section 4.5 not as detailed in promoting sustainability
