Evaluation Comments

CherryRoad Technologies

Strengths

Team Qualifications and Experience: Of the 9 team members proposed as key individuals, 8 had public sector experience; 3 references provided that were all public sector hosting with a combination of EBS, PeopleSoft, and Hyperion.

Business Plan: Private cloud for Metro (public sector) that is secure and scalable. Communication plan with Metro.

Weaknesses

Team Qualifications and Experience: No Hyperion experience with key individuals listed; insufficient information provided on their ability, skill, financial strength, and number of years's experience in providing the required services; company appears to be doing too many services and not enough focus on hosting.

Business Plan: Overall generic Business Plan; no detailed plan of approach provided; no timeline provided; services provided included application support and development, which was not in the scope; did not mention incorporating migration of Hyperion and PeopleSoft; data centers were subcontracted to different organizations; no listing of proper milestones.

Denovo Ventures, LLC

Strengths

Team Qualifications and Experience:

Business Plan: Disaster recovery options and procedures appear to be thoroughly documented.

Weaknesses

Team Qualifications and Experience: Company has gone through a number of mergers and acquisitions; failed to provide customer references; no or very little information on qualifications to hosting Oracle applications; 6 key resources, 2 of which were management, and none of which had public sector hosting experience; hosting services were only added to their line of business in 2007.

Business Plan: Business Plan was generic; did not distinguish how they would deliver hosting; plan is limited in details of how they would migrate and setup Hyperion, PeopleSoft, and EBS; plan does not reflect any experience with hosting Hyperion and PeopleSoft; risks were generic and not specific to this RFP.

Mercury Technology Group

Strengths

Team Qualifications and Experience: Been in operation for 23 years, specializing in Oracle hosting services.

Business Plan:

Weaknesses

Team Qualifications and Experience: Did not complete reference questionnaires; no resumes provided, just a total number of years' experience; limited information regarding their financial strengths and services; key individuals were primarily admin and management, and only 5 named with none tied to Metro's Oracle applications.

Business Plan: Many of the requested elements were omitted entirely or only generically included; timeline provided but the steps were not clearly identified; no real explanation of the scope; data center managed by a subcontractor.

Oracle America, Inc.

Strengths

Team Qualifications and Experience: Experience with Metro; OMCS is a managed service provider and dedicated line of business; experience with hosting all applications listed within the RFP; all 3 references were for public sector hosting, with at least 1 or more of the Oracle applications tied to this scope of work.

Business Plan: Clearly documented thorough understanding of the scope; plan of approach is thorough and tailored to Metro's applications and services; migration plan included thorough and complete information; implementation plan environment phases takes into account all of Metro's requirements; @Oracle Model in separate public cloud as it relates to security and growth needs; disaster recovery options and procedures to cover all aspects of the scope.

Weaknesses

Team Qualifications and Experience: Key managers were not specific.

Business Plan:

Strengths

Team Qualifications and Experience: Founded in 2001 in providing managed hosting services; title and function of resources listed cover all Oracle applications.

Business Plan: Core business is managing application hosting and data center operations; critical factors listed appear to cover all key items; detailed architecture of all 3 Oracle applications and distinguished the scope between all 3; location of data centers and data centers were custom built.

Weaknesses

Team Qualifications and Experience: Did not provide customer references; key personnel states "Oracle Application Engineer" without being specific to which Oracle application; unclear if any public sector experience provided; limited information as it relates to financial stability; no listing of Hyperion experience.

Business Plan: Detailed migration plan was a sample with old dates and generic; key aspects and deliverables not defined; quality assurance plan was very limited; disaster recovery options were generic; risk factors and mitigation were generic.
