Weaknesses: Proposed a software service rather than a consultant services as outlined in the scope of work; their tax enforcement capabilities lacked detail; parcel identification lacks detail; "STR Helper does not search local property management sites for STRs in our nightly batch process"; proposal failed to identify which parcels do not have permits which would require cross referencing by Metro; escalate issues to codes; failed to provide reference project details.

Weaknesses: Frequency on reporting; Proposed a software service rather than a consultant services as outlined in the scope of work; proposed experience was detailed but was not of similar size, scope, and/or complexity.
