


The VIP System is just one of the expanded services we had been working on to serve our customers better. It has even more capabilities as we move into the future.

1. First...have your correct information at hand: You will need your contractor User I.D. Number and permit tracking number for each job.



2. Dial In:
880-2686
From any touchtone telephone

3. After your connection is made, you make your selections from the options offered, provide the requested information and be sure to write down your confirmation number.

When you first begin using the VIP System, you will need to listen carefully to the directions in each message. Soon you will be familiar with the system and you will only need to listen to the portion of a message that you need.
