No sir, we haven't outlined direction for notifying COB on incidents yet. I have been working with Mr Pinckley and Legal Dept Atty Gross regarding the matter, however, while we aren't an MNPD operation, we notify on incidents that have occurred with MNPD and NFD and work under guidelines provided by those departments for release of information and notifications. I feel it is my responsibility to ensure all involved parties are in agreement with notifications that are generated from the dispatch center, so I have been working toward that end.

Our office has been contacted separately, but this is something that will need to be worked in conjunction with our current guidelines for notifications, which will affect the delivery of notices.

After reading Mr Weeden's email last night, along with the communication I've already been having with Mr Pinckley and Ms Gross, I feel the goal can be accomplished without an MOU and will be back in contact to advise logistics of how the notification will be best facilitated.

Thank you for your understanding as all the facets of this process for DEC are considered and implemented.
