#### **SUBSTITUTE RESOLUTION NO. RS2017-566**

### A resolution expressing the Metropolitan Council's support for the Medical Cannabis Access Act medical cannabis legislation, SB 0803/HB 0495 and SB 1119/HB 0830, currently pending before the Tennessee General Assembly.

WHEREAS, <u>Senator Steve Dickerson of Nashville, Tennessee and Representative Jeremy Faison of Cosby,</u> <u>Tennessee have announced an intention to introduce legislation before the Tennessee General Assembly</u> <u>to legalize cannabis for medical purposes; and</u>

WHEREAS, Senator Sara Kyle of Memphis and Representative Sherry Jones of Nashville have <u>also</u> recently introduced legislation before the Tennessee General Assembly to legalize marijuana for medical purposes for this purpose; and

WHEREAS, at this time, twenty-eight (28) states have legalized marijuana cannabis for medicinal uses; and

WHEREAS, this <u>such</u> legislation will allow physicians to provide treatment for citizens of Nashville suffering from a variety of medical conditions, including cancer, Alzheimer's Disease, amyotrophic lateral sclerosis (ALS), post-traumatic stress disorder (PTSD), and seizures; and

WHEREAS, in light of the opioid epidemic currently afflicting Tennessee and the nation, it is important to look for alternative sources for pain management; and

WHEREAS, this legislation would bring much needed relief to individuals suffering from medical conditions residing in Nashville and Davidson County and across the state of Tennessee.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That the Metropolitan County Council hereby goes on record as supporting the state legislation proposed under <u>the Medical Cannabis Act, SB 0803/ HB 0495 and</u> the Medical Cannabis Access Act, SB 1119 / HB 0830, <u>both</u> pending before the Tennessee General Assembly.

Section 2. <u>That</u> the Metropolitan County Council further requests that the Davidson County Delegation to the Tennessee General Assembly support <u>the Medical Cannabis Act, SB 0803 / HB 0495 and</u> the Medical Cannabis Access Act, SB 1119 / HB 0830, <del>and</del> <u>as well as</u> any such legislation that further ensures the health of residents of Davidson County.

Section 3. <u>That</u> the Metropolitan Clerk is directed to send a copy of this Resolution to each member of the Davidson County Delegation to the Tennessee General Assembly.

Section 4. That this Resolution shall take effect from and after its adoption, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

### An ordinance naming the Bridge over I-40 / I-65 between $11^{th}$ Avenue North & $12^{th}$ Avenue North along the 1100 block of Jefferson Street in honor of Bishop Joseph W. Walker, III.

WHEREAS, Bishop Joseph Warren Walker, III, serves as pastor of the Mt. Zion Baptist Church in Nashville, Tennessee; and

WHEREAS, Bishop Walker received a Bachelor of Arts degree from Southern University in Baton Rouge, Louisiana; a Master of Divinity degree from Vanderbilt University, and a Doctor of Ministry degree from Princeton Theological Seminary. He holds two honorary Doctorates from Meharry Medical College and Southern University respectively. He is also a member of the Omega Psi Phi Fraternity and the Kappa Kappa Psi Band Fraternity; and

WHEREAS, Bishop Walker currently serves as the International Presiding Bishop of Full Gospel Baptist Church Fellowship, International which consists of hundreds of churches across the globe connected by common theologies of the church experience. In July 2013, he was chosen to succeed International Presiding Bishop Paul S. Morton, Sr. in 2015; and

WHEREAS, Bishop Walker was born in Shreveport, Louisiana to Deacon Joseph and Rosa Walker; and in 1992, at the age of 24, he began his pastorate at Mt. Zion with 175 members. WHEREAS, Bishop Walker is a regular guest on the Rickey Smiley Radio Show as well as a host of other nationally syndicated radio shows across the United States. He also has been a guest on CNN, The CBS Morning News, The Roland Martin Show and B.E.T. He also authors a monthly Op-Ed column in *The Tennessean* newspaper entitled "Reset", and he was featured in the world premiere of the film "Black, White and Blues" directed by the award-winning Mario Van Peebles; and

WHEREAS, Bishop Walker is the visionary behind Mt. Zion's Youth & Children's Ministry, which includes the Judah Generation Youth Choir. Likewise, he is the visionary behind Mt. Zion's Kid-Zone—a youth-centered facility for youth worship, tutorial services and outreach; and behind Mt. Zion's College Ministry, which provides to thousands of college students a positive environment for academic adroitness and spiritual growth; and

WHEREAS, in 2014, in the wake of social unrest following events in Ferguson, Missouri, Bishop Walker galvanized the city together and founded Nashville Unites, and organization that is rapidly becoming a national model of collaboration for addressing issues that divide communities. Nashville Unites partners with those in the community working toward positive change and provides strategy and real solutions; and

WHEREAS, throughout his life and ministry, Bishop Walker has demonstrated a caliber of leadership well beyond his years. Emerging from humble beginnings, he has become a teacher, humanitarian, philanthropist, businessman, community volunteer, husband, father and pastor, as set forth in more detail in the attached biography; and

WHEREAS, Section 13.26.010 of the Metropolitan Code provides that no building or structure of the Metropolitan Government may be named except pursuant to an ordinance duly adopted by the Metropolitan Council; and,

WHEREAS, it is fitting and proper that Bishop Joseph W. Walker III be recognized for his many contributions to the Nashville community as set forth above by naming the interstate overpass bridge at the 1100 block of Jefferson Street in his honor.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That the bridge structure of the interstate overpass bridge over I-40 / I-65 between 11<sup>th</sup> Avenue North & 12<sup>th</sup> Avenue North along the 1100 block of Jefferson Street is hereby named the "Bishop Joseph W. Walker III Overpass."

Section 2. This Ordinance shall take effect from and after its adoption, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

#### ORDINANCE NO. BL2017-581

Mr. President -

I move to amend Ordiance No. BL2017-581 as follows:

I. By amending Section 1 by deleting referenced Section H it in its entirety and substituting in lieu thereof the following new subsections H. through L. to the end of Section 2.24.300 as follows:

H. The metropolitan auditor, in conducting any reviews or audits, shall have full authority to conduct an independent investigation of any and all departments, boards and commissions of the Metropolitan Government, as well the performance of contracts by entities that contract with the Metropolitan Government. Such authority shall include, but is not limited to, the ability to review, research, and conduct interviews, along with the ability to have access to any and all necessary documentation. All metropolitan government, shall cooperate fully with the metropolitan auditor during such review or audit. Should the metropolitan auditor not be able to conduct such an independent audit due to an unwillingness to cooperate by departments, boards, commission or entities, the metropolitan auditor shall report such findings to the metropolitan audit committee and to the Budget and Finance Committee of the Metropolitan Council for further action. The metropolitan auditor shall have the authority to establish guidelines for conducting such audits and reviews.

#### H. Access to Records and Personnel.

To the extent permitted by the Metropolitan Charter the Division of Metropolitan Audit, with strict accountability for confidential and safeguarding records and information, shall have access to all Metropolitan Government's records, agreements, information systems, physical properties, and personnel. Such authority shall include but is not limited to, the ability to review, research, and conduct interviews, along with the ability to have access to any and all necessary documentation as described in this subsection. To the extent permitted by the Metropolitan Charter, all Metropolitan Government departments, boards, commissions, officers, agencies, or offices, along with all entities contracting with the Metropolitan Government shall co-operate fully with the Metropolitan Auditor during any such review or request to the fullest extent of applicable law. Any failure to cooperate with the Metropolitan Auditor shall be reported to the Audit Committee, Finance Director, Director of Law, and the Metropolitan Council.

#### I. <u>Other Audit Services.</u>

1. In addition to financial or performance services, the Division of Metropolitan Audit shall establish a process by which suspected illegal, improper, wasteful, or fraudulent activity could be reported. The Metropolitan Auditor shall investigate, or cause to be investigated, all activity reported by this process. The disposition of all reports shall be communicated to the Metropolitan Nashville Audit Committee, Metropolitan Mayor, and Department of Law.

2. No employees of the Metropolitan Government or its agencies shall suffer any retaliatory action for reporting to or cooperating with the Division of Metropolitan Audit or the Audit Committee as contemplated in TCA 9-3-406 and TCA 50-1-304.

3. It shall be the duty of employees of the Metropolitan Government or its agencies to report any known act of intentional illegal, intentional fraudulent, or intentional improper use of government funds.

#### J. <u>Notice of Instance of Fraud, Waste, and Abuse</u>.

All reports of unlawful conduct completed in accordance with the State of Tennessee Local Government Instances of Fraud Reporting Act involving Metropolitan Government departments, boards, commissions, officers, or agencies shall be communicated in a timely manner to the Metropolitan Auditor. Such reports shall also be communicated to the office of the Comptroller of the Treasury if so required by state law.

#### K. <u>Notice of Audit Activities.</u>

The engagement plans and final reports for all financial, performance, and other audit activities conducted on behalf of Metropolitan Government departments, boards, commissions, officers, agencies, or offices shall be communicated in a timely manner to the Metropolitan Auditor.

#### L. <u>Scope of Services.</u>

To the extent permitted by the Metropolitan Charter the Division of Metropolitan Audit is authorized to conduct financial audits, performance audits, or other audit services including investigation and disposition of reported incidents of fraud as contemplated above in subsection I of this section and the Metropolitan Charter, concerning any department, board, commission, officer, agency, or office of the Metropolitan Government which receives direct services from or to which funds are appropriated by the Metropolitan Government or for which the Metropolitan Government provides a guarantee for long-term indebtedness. Departments, boards, commissions, officers, agencies, and offices of the Metropolitan Government means those entities which encompass all of the governmental and corporate functions previously performed by Davidson County and the City of Nashville existing at the formation of the Metropolitan Government, and any public entity whose existence is created or authorized by the Metropolitan Charter or the Metropolitan Council.

#### **SUBSTITUTE ORDINANCE NO. BL2017-585**

### An ordinance amending chapters 8.12 and 8.20 of the Metropolitan Code of Laws regarding miscellaneous animal control regulations.

BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. Section 8.12.030 of the Metropolitan Code of Laws is hereby amended by adding the following as a new subsection B and renaming the other subsections as appropriate:

B. No person shall fail unreasonably or cause another person to fail unreasonably to provide adequate food, water, care or shelter to any animal in the person's custody or to abandon any animal in the person's custody. For the purposes of this section, "shelter" shall mean a structure or enclosure which provides an animal with protection from the elements, which structure or enclosure must have a roof, floor and three sides, and be of sufficient size as to allow each animal to stand up, lie down and turn around in a natural position. "Elements" as used herein refers to weather conditions, including the following inclement weather conditions: freezing temperatures, a heat index of 95 degrees Fahrenheit (95° F) or above as determined by the National Weather Service, thunderstorms, or tornados.

<u>B. No person shall fail to provide protection to pregnant animals, nursing females, or animals less than 6 months old from the following inclement weather conditions: freezing temperatures, a heat index of 95 degrees Fahrenheit (95° F) or above as determined by the National Weather Service, thunderstorms, or tornados.</u>

Section 2. Section 8.12.030 of the Metropolitan Code of Laws is hereby further amended by deleting subsection C.6 (now D.6 under this Substitute Ordinance) in its entirety, renumbering the remaining subsections as necessary.

Section 3. Section 8.12.030 of the Metropolitan Code of Laws is hereby further amended by inserting the following as a new subsection E, and renumbering the remaining subsections:

E. No dog shall be kept outside during a period of extreme weather, including without limitation a heat index of ninety five degrees Fahrenheit (95° F) or above as determined by the National Weather Service, freezing temperatures, thunderstorms, or tornados.

Section <u>4</u> 2. Section 8.20.040 of the Metropolitan Code of Laws is hereby amended by deleting it in its entirety and substituting the following in lieu thereof:

8.20.040 - Care of confined animals.

Any person who shall impound or cause to be impounded, in any pound or other place, any creature, shall supply to the same during such confinement a sufficient quantity of good, wholesome food and water. <u>Such persons</u> and shall further provide protection from the elements inclement weather conditions, as defined listed in section 8.12.030.B of this title, to any creature that is pregnant, a nursing female, or less than six (6) months old.

Section 5- 3. This Ordinance shall take effect from and after its enactment, the welfare of the Metropolitan Government of Nashville and Davidson County requiring it.

Section 7. That Chapter 8.20 of the Metropolitan Code of Laws is hereby further amended by deleting the phrase "within the urban services district" in section 8.20.130 thereof.

#### SUBSTITUTE ORDINANCE NO. BL2017-588

## An ordinance amending Section 15.64.032 of the Metropolitan Code by amending the graduated storm water user fee schedule and amending Section 15.64.034 of the Metropolitan Code to require individual storm water project reports.

WHEREAS, section 15.64.032 of the Metropolitan Code of Laws establishes a storm water utility and a system of user fees for parcels of property in Davidson County; and

WHEREAS, fairness to all storm water utility users and the generation of adequate funding to perform storm water management and flood control projects necessary for the safety and welfare of the citizens of Davidson County require that changes be made to the current system of storm water user fees; and

WHEREAS, fairness to all storm water utility users further requires an equitable distribution of stormwater resources, projects and investments across Nashville and Davidson County.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. Table 15.64.032 of the Metropolitan Code of Laws, entitled "Graduated Storm Water User Fee Schedule," is hereby replaced in its entirety with the following:

Section 2. Section 15.64.034 of the Metropolitan Code of Laws, entitled "Reports of Stormwater division", is hereby amended by designating the current language as Subsection A and adding the following provision as Subsection B:

B. In addition to the annual reports required in subsection A, the director of MWS shall submit to metro council a report for each proposed stormwater project prior to its implementation. This report shall include the plans and expected expenditures for the project. Metro council shall thereafter, by resolution, approve or deny any project proposed under this subsection.

Section 3. This Ordinance shall take effect from and after its passage, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

#### THIRD SUBSTITUTE ORDINANCE NO. BL2017-555

An ordinance to amend Title 17 of the Metropolitan Code of Laws, the Zoning Ordinance of The Metropolitan Government of Nashville and Davidson County, by changing from R10 to RS10 zoning on various properties along Clearview Drive, Crescent Road, Estes Road, Westmont Avenue and Woodmont Circle, located southwest of Wilson Boulevard and Woodlawn Drive, (approximately 30.19 acres), all of which is described herein (Proposal No. 2017Z-005PR-001).

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That Title 17 of the Code of Laws of The Metropolitan Government of Nashville and Davidson County, is hereby amended by changing the Official Zoning Map for Metropolitan Nashville and Davidson County, which is made a part of Title 17 by reference, as follows:

Section 2. Be it further enacted, that the Metropolitan Clerk is hereby authorized and directed, upon the enactment and approval of this ordinance, to cause the change to be on various maps of said Official Zoning Map for Metropolitan Nashville and Davidson County, as set out in Section 1 of this ordinance, and to make notation thereon of reference to the date of passage and approval of this amendatory ordinance.

Section 3. Be it further enacted, that this ordinance take effect immediately after its passage and such change be published in a newspaper of general circulation, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.


