SUBSTITUTE RESOLUTION NO. RS2017-678

A resolution requesting the Metropolitan Transit Authority to provide at least ten percent (10%) of its advertising space from its unsold advertising inventory to other Metropolitan departments, boards and commissions to provide public service advertisements regarding local government services.

WHEREAS, the Metropolitan Transit Authority has the power and authority pursuant to the Metropolitan Charter for the complete operation of the public transportation system in Nashville and Davidson County; and

WHEREAS, the Metropolitan Transit Authority is governed by the MTA Board of Directors, which is responsible for the general supervision of the transit system in Nashville; and

WHEREAS, the Metropolitan Transit Authority provides advertising space on the exterior and interior of its buses, as well on over 650 bus benches throughout the Nashville Metropolitan area, that is easily viewable by bus riders and the public at large; and

WHEREAS, governmental agencies, including the Metropolitan Transit Authority, should make every effort to provide for public service information and inform the public as to the availability of local government services; and

WHEREAS, in furtherance of this goal, it is fitting and proper that the Metropolitan Transit Authority make available at least ten percent (10%) of its advertising space to Metropolitan departments, boards and commissions to allow those entities to advertise their public services, announcements and other information for the benefit of the public.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. The Metropolitan County Council hereby goes on record as requesting the Metropolitan Transit Authority to make available at least ten percent (10%) of its advertising space on buses, shelters, benches and terminal facilities from its unsold advertising inventory to Metropolitan departments, boards and commissions at no charge to allow those entities to advertise their public services, announcements and other information for the benefit of the public.

Section 2. The Metropolitan County Council hereby further goes on record as requesting that the Metropolitan Transit Authority make such advertising space available on an "as available" basis, and pursuant to the Authority's other advertising policies, until such time as the Authority's obligations under current third-party agreements with advertising contractors are expired, whereupon the Authority will require a minimum set-aside of ten percent (10%) of advertising space for Metropolitan Government departments, boards and commissions.

Section 3. The Metropolitan County Council hereby further goes on record as requesting that the Metropolitan Transit Authority produce a report annually documenting (a) the entities that used this service; (b) the nature of their campaigns (*i.e.*, what was advertised); (c) the duration of the campaign; (d) the inventory used; and (e) the dollar value of the advertising space provided.

Section $\frac{2}{2}$. The Metropolitan Clerk is directed to send a copy of this Resolution by U.S. mail or electronic mail to each member of the Metropolitan Transit Authority Board of Directors and to Steve Bland, the MTA Chief Executive Officer.

Section $\frac{3}{5}$. That the Metropolitan Transit Authority is further requested to respond to the Council as to the feasibility of and/or action taken in compliance with the request stated in Sections $\frac{1}{5}$ hereof not later than sixty (60) days from the adoption of this Resolution.

Section 4. 6. This Resolution shall take effect from and after its adoption, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

Mr. President,

I move to amend Resolution No. RS2017-690 as follows:

Section 1. That the phrase "subject to the conditions contained in Section 2 of this Resolution" is inserted at the end of Section 1.

Section 2. That a new Section 2 is inserted in the Resolution as follows:

Section 2. The Metropolitan Mayor may only execute the Cooperation Agreement if the following conditions have been satisfied:

- (a) The Cooperation Agreement is revised to include the following:
 - i. A requirement that, if any land, building, structure, or other improvement is used for any for-profit activities, including without limitation any office, commercial, retail, or industrial use ("for-profit parcel"), such for-profit parcel shall be subdivided from the remaining Housing Project real property and, for such for-profit parcel, MDHA shall make a payment in lieu of taxes ("PILOT") that is equal to the real property taxes that would be due for such for-profit parcel if it were not owned by a housing authority;
 - ii. A requirement that, if any land, building, structure, or other improvement is used for housing units where the residents are not screened for an income eligibility requirement ("market housing parcel"), such market housing parcel shall be subdivided from the remaining Housing Project real property and, for such market housing parcel, MDHA shall make a PILOT that is equal to the real property taxes that would be due for such market housing parcel if it were not owned by a housing authority;
 - iii. Notwithstanding anything to the contrary in subsections (i) and (ii), if a for-profit parcel or a market housing parcel also contains housing units where the residents are screened for an income eligibility requirement ("income eligibility housing"), then the PILOT due by MDHA for that parcel shall be: (A) the amount due under subsections (i) or (ii) as applicable ("Base PILOT Amount"); (B) minus an amount equal to the Base PILOT Amount times the ratio determined by dividing the rentable square feet of income eligibility housing by the total square feet of the parcel; provided that "rental square feet" shall mean the actual usable square footage of the income eligibility housing

- units plus a pro-rata share of building common areas; and (C) plus Fifty Dollars (\$50.00) per unit of income eligibility housing;
- iv. A reasonable termination date for the Cooperation Agreement not to exceed ten (10) years after approval by the Metropolitan Council; and
- (b) The revised Cooperation Agreement is approved by a resolution of the Metropolitan Council.

Section 3. That the existing Section 2 of the resolution is renumbered to be Section 3.

An ordinance adopting the 2017-2018 through 2022-2023 Capital Improvements Budget for The Metropolitan Government of Nashville and Davidson County as the official Capital Improvements Budget of The Metropolitan Government of Nashville and Davidson County for Fiscal Year 2017-2018.

WHEREAS, Section 6.13 of the Charter of The Metropolitan Government of Nashville and Davidson County provides for the preparation and establishment of a capital improvements budget for the Metropolitan Government including a program of proposed capital expenditures for the ensuing fiscal year and the next five fiscal years thereafter; and,

WHEREAS, the various departments, boards, commissions and agencies of the Metropolitan Government have submitted their capital improvement project requests; and,

WHEREAS, the Metropolitan Planning Commission, in accordance with Section 11.504(k) of the Metropolitan Charter, has reviewed the capital improvement project requests and, upon evaluating the overall needs of the community, has recommended to the Mayor a Capital Improvements Budget for fiscal year 2017-2018 including a program of proposed expenditures for the ensuing five (5) years; and,

WHEREAS, the Mayor and the Director of Finance have reviewed the capital improvement project requests and recommended program of proposed expenditures and have established a priority of undertaking and financing the capital improvement projects; and,

WHEREAS, it is determined that this Capital Improvements Budget and Program represents an appropriate evaluation of the needs of The Metropolitan Government of Nashville and Davidson County and a systematic and orderly framework within which to provide for them; and,

WHEREAS, these findings and recommendations have been bound into a report entitled, "2017-2018 to 2022-2023 Capital Improvements Budget"; and,

WHEREAS, two (2) copies of said report are on file in the office of the Metropolitan Clerk.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That the recommended program contained in the 2017-2018 to 2022-2023 Capital Improvements Budget is hereby adopted as the official Capital Improvements Budget of The Metropolitan Government of Nashville and Davidson County for fiscal year 2017-2018.

Section 2. That there shall be no authorization for expenditure of funds for the construction of any building, structure, work, or improvement, unless such project is included in and in conformance with the adopted 2017-2018 to 2022-2023 Capital Improvements Budget, except to meet a public emergency threatening the lives, health, or property of the inhabitants, when passed by two-thirds vote of the membership of Council.

Section 3. That no fund shall be encumbered nor expended for a capital improvements project unless such project is included in and in conformance with the adopted 2017-2018 to 2022-2023 Capital Improvements Budget.

Section 4. That this Capital Improvements Budget may be amended by resolution at any time during the year to add a capital improvements project to the 2017-2018 to 2022-2023Capital Improvements Budget, when adopted by two-thirds vote of the membership of the Council.

Section 5. That this ordinance shall take effect from and after its final passage, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it, but that the Capital Improvements Budget and Program of The Metropolitan Government of Nashville and Davidson County for fiscal year 2017-2018shall not take effect until July 1, 2017.

ORDINANCE NO. BL2017-646

Mr. President -

I move to amend Ordinance No. BL2017-646 as follows:

I. By deleting all language after the enacting clause and substituting instead the following:

Section 1. That Chapter 13.08 of the Metropolitan Code of Laws be amended by adding a new section 13.08.080 as follows:

13.08.080 Deployment of surveillance or electronic data gathering devices onto public rights of way requires Metropolitan Council approval

A. For the purposes of this section, the following terms shall be defined as follows:

- (1) "Public right-of-way" shall mean any street, avenue, boulevard, highway, sidewalk, alley or public <u>outdoor</u> space which is within the Metropolitan Government of Nashville and Davidson County besides facilities or areas of facilities not open to the general public and highways that comprise the Dwight D. Eisenhower National System of Interstate and Defense Highways.
- (2) "Surveillance technology" shall mean any electronic surveillance device, hardware, or software that is capable of collecting, capturing, recording, retaining, processing, intercepting, analyzing, monitoring, or sharing audio, visual, digital, location, thermal, biometric, or similar information or communications specifically associated with, or capable of being associated with, any specific individual or group; or any system, device, or vehicle that is equipped with an electronic surveillance device, hardware, or software.
 - (a) "Surveillance technology" includes, but is not limited to: (i) international mobile subscriber identity (IMSI) catchers and other cell site simulators; (ii) automatic license plate readers; (iii) closed-circuit television cameras; (iv) biometric surveillance technology, including facial, voice, iris, and gait-recognition software and databases; (v) mobile DNA capture technology; (vi) x-ray vans; (vii) video and audio monitoring and/or recording technology, such as surveillance cameras and wide-angle cameras; (viii) surveillance enabled or capable lightbulbs or light fixtures; (ix) tools, including software and hardware, used to gain unauthorized access to a computer, computer service, or computer network; (x) social media monitoring software; (xi) throughthe-wall radar or similar imaging technology; (xii) passive scanners of radio networks; (xiii) long-range Bluetooth and other wirelessscanning devices; and (xiv) radio-frequency I.D. (RFID) scanners. The enumeration of surveillance technology examples in this subsection shall not be interpreted as an endorsement or approval of their use.

- (b) "Surveillance technology" does not include the following devices or hardware, unless they have been equipped with, or are modified to become or include, a surveillance technology as defined in Section 13.08.080(A)(2)(a): (i) routine office hardware, such as televisions, computers and printers, that is in widespread public use and will not be used for any surveillance or law enforcement functions; (ii) Parking Ticket Devices (PTDs); (iii) manually operated non-wearable handheld digital cameras, audio recorders, and video recorders that are not designed to be used surreptitiously and whose functionality is limited to manually capturing and manually downloading video and/or audio recordings; (iv) surveillance devices that cannot record or transmit audio or video or be remotely accessed, such as image stabilizing binoculars or night vision goggles; (v) manually operated technological devices used primarily for internal communications among Metropolitan Government entities and are not designed to surreptitiously collect surveillance data, such as radios and email systems; (vi) wayfinding technological devices which enable the user to determine global positioning, location within a built environment, or orientation; and (vii) Metropolitan Government wireless local area networking and Metropolitan Government databases that do not contain any data or other information collected, captured, recorded, retained, processed, intercepted, or analyzed by surveillance technology.
- (c) "Surveillance technology" does not include technology or equipment that collects data in anonymized form or that immediately deletes or destroys non-anonymized collected data.
- (3)"Install" or "Installing" shall mean attaching to an existing building, pole, overpass, roadway, sidewalk, natural area, or other structure in a manner that facilitates the permanent or semi-permanent presence of the applicable device. "Install" or "Installing" shall not mean operating a mobile or portable device intended to be present for a time of limited and discernable length.
- B. "License plate scanner" shall mean one (1) or more fixed high-speed cameras combined with computer algorithms to convert images of license plates into computer-readable data. shall mean any device principally designed and primarily used for determining the ownership of a motor vehicle, the mileage or route traveled by a motor vehicle, the location or identity of a motor vehicle, or the identity of a motor vehicle's occupants.
- C. Beginning July 1, 2017, approval by the Metropolitan Council, <u>by a resolution adopted after a public hearing</u>, shall be required prior to any of the following actions by the Metropolitan Government of Nashville or Davidson County, the departments, boards or commissions thereof, or any individual or entity acting upon its behalf:
 - $\underline{\text{(1)}}$ Installing unmanned surveillance technology onto or within the public right of way, <u>unless</u>:
 - (a) the same type of surveillance technology is already in use by the entity: and

- (b) the number of new devices does not represent more than a fifty percent (50%) increase in the total number of devices of the same type already in use by the department, board, or commission seeking installation, as compared to the number of devices in use the time of this ordinance's implementation or at the time of the last such approval by the Metropolitan Council, whichever is more recent.
- (2) Entering into an agreement with a private entity to acquire, share or otherwise use surveillance technology or the information it provides if such agreement includes exchange of any monetary or any other form of consideration from any source, including the assessment of any additional fees, interest, or surcharges on unpaid fines or debts absent approval by the Metropolitan Council;
- (3) Accepting state or federal funds or in-kind or other donations for surveillance technology;
- (4) Acquiring new surveillance technology, including but not limited to procuring such technology without the exchange of monies or consideration; or
- (5) Entering into an intergovernmental agreement regarding the installation of surveillance technology or use of the information it provides within the Dwight D. Eisenhower National System of Interstate and Defense Highways.
- D. The approval by the Metropolitan Council for any action set forth in subsection 13.08.080(C) above shall be granted only upon the determination that the benefits to the citizens and residents of Nashville and Davidson County outweigh the costs; that the proposal will safeguard civil liberties and civil rights; and that, in the judgment of the Metropolitan Council, no alternative with a lesser economic cost or impact upon civil rights or civil liberties would be as effective.
- E. This section shall not apply to acquisition or use of surveillance technology by or on behalf of law enforcement that is used on a temporary basis for the purpose of a criminal investigation supported by reasonable suspicion, or pursuant to a lawfully issued search warrant, or under exigent circumstances as defined in case law.
- F. This section shall not apply to surveillance technology installed for the purpose of securing a building or facility from unlawful entry or unauthorized access.
- G. It is unlawful to operate any license plate scanner installed onto or within the public right of way, with the exception of uses that meet each of the following requirements:
 - (1) The license plate scanner is used solely and exclusively in conjunction with a vehicle emissions sensor as part of an emissions inspection program authorized under local, state or federal law:
 - (2) The data from the license plate scanner and vehicle emissions sensor is used solely and exclusively for purposes of determining compliance with vehicle emissions standards and aggregating data in a manner which does not allow the identification of a person or persons;

- (3) A determination by the vehicle emissions sensor that a vehicle identified by the license plate scanner is not in compliance with applicable emissions standards shall not lead to any penalty or punitive action against the registered vehicle owner;
- (4) No fewer than two (2) such license plate scanners shall be in operation within Davidson County at any given time; and
- (5) Data that can be used to pair a specific vehicle's license plate number, VIN, or other unique identifier with a specific geographic location shall not be retained for more than one week.
- H. <u>Notwithstanding the foregoing, the provisions of this section shall not apply to the Nashville Electric Service, the Metropolitan Nashville Airport Authority, the Metropolitan Development and Housing Agency, and the Metropolitan Transit Authority.</u>

Section 2. This ordinance shall take effect from and after its passage, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

SUBSTITUTE ORDINANCE NO. BL2017-688

An ordinance amending section 16.04.200 of the Metropolitan Code of Laws to permit the construction and use of electric fences pursuant to certain standards.

WHEREAS, the current Metropolitan Code of Laws expressly prohibits the use of electric fences in all zoning districts, except in instances involving the keeping of domestic animals and wildlife in certain zoning districts; and

WHEREAS, electric fencing has been approved on an individual basis by the Metropolitan Government Fire and Building Codes Appeal Board for use in industrially zoned businesses, providing a safe and effective means of securing inventory, equipment and other valuables.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. Section 16.04.200 of the Metropolitan Code of Laws is amended by deleting subsection A thereof in its entirety and substituting the following in lieu thereof:

16.04.200 - Fences.

Fences shall be constructed in accordance with the requirements of this code. The location and height of fences shall be controlled by the metropolitan zoning regulations, except for the following additional requirements.

A. Electric fences are permitted only if compliant with the following requirements:

- 1. In all AG, AR2a, RS80, RS40, RS30, RS20, R80, R40, R30, and R20 zoning districts, electric fences are permitted if the property satisfies all of the requirements of Section 17.16.330B. of the metropolitan zoning code regarding the keeping of domestic animals/wildlife on the property and all necessary permits have been issued; or
- 2. In all non-residential zoning districts, the construction and use of electric fences are permitted, subject to the following standards:

a. Electrification:

- (i) The energizer for electric fences must be driven by a commercial storage battery not to exceed 12 volts DC. The storage battery is charged primarily by a solar panel. However the solar panel may be augmented by a commercial trickle charger.
- (ii) The electric charge produced by the fence upon contact shall not exceed energizer characteristics set forth in paragraph 22.108 and depicted in Figure 102 of International Electro technical Commission (IEC) Standard No. 60335-2-76, attached hereto as an Exhibit.

- b. Perimeter fence or wall: No electric fence shall be installed or used unless completely surrounded by a non-electrical fence or wall not less than six feet (6') in height.
- c. Location: Electric fences shall be permitted on any non-residential outdoor storage areas.
- d. Height: Electric fences shall not <u>exceed the maximum height permitted by Title 17 of the Metro Code of Laws</u> have a minimum height of then feet (10').
- e. Warning signs: Electric fences shall be clearly identified with warning signs that read: "Warning-Electric Fence" at intervals of not less than thirty linear feet (30').
- f. Accessibility: A Knox Box or similar device used to hold access keys for fire departments, police departments and emergency medical services shall be installed for purposes of minimizing damage and to allow access to the enclosed area. Installation may be subject to the oversight and direction of the Nashville Fire Department.

Section 2. This Ordinance shall take effect from and after its passage, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

EXHIBIT A

PUBLIC RECORDS POLICY OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY

- 1. This Public Records Policy (the Policy) is adopted pursuant to 2016 Tennessee Laws Pub. Ch. 722 (H.B. 2082)(the State Act), and has an effective date of July 1, 2017.
- 2. The Metropolitan Public Records Commission shall have the authority to establish rules and regulations expanding upon and interpreting the provisions of this Policy.
- 3. Until such time as the Public Records Commission has adopted such rules and regulations, the provisions of Mayor Megan Barry's Executive Order No. 33 shall provide any additional guidance needed to expand upon and interpret this Policy, except to the extent inconsistent herewith.
- 4. Scope: This Policy shall automatically apply to all documents, papers, records, books, and books of account in all offices of the Metropolitan Government and county elected officials, including, but not limited to, the county clerk, the county register, the county trustee, the sheriff, the assessor of property; the pleadings, documents, and other papers filed with the clerks of all courts including the courts of record, general sessions courts; all documents created by any office or department of the old Davidson County or former city of Nashville, or of any office, department or agency of the Metropolitan Government, including boards and commissions (the Metro Departments).

Any Metro Department may opt out of this Public Records Policy, subject to the following conditions:

- A. The Metro Department's request to opt out of this Policy must be approved by the Public Records Commission.
- B. Any Metro Department that opts out of this Policy must adopt a public Records Request Policy of its own, compliant with the State Act and approved by its appropriate governing authority.
- c. Any Metro Department that opts out of this Policy must designate its own Public Records Request Coordinator and provide current contact information for that person to the Metropolitan Clerk.
- D. The Public Records Commission and the Metropolitan Clerk shall keep a current list of all departments that have opted out of this Policy, and shall make this list and the list of the exempt departments' Public Records Request Coordinators available to the public online.

Notwithstanding the above, the following Metro Departments are exempted from this Policy and shall adopt their own Public Records Policy and designate their own Public Records Request Coordinator and keep the Metropolitan Clerk advised of same:

- A. Metropolitan Nashville Police Department
- B. Justice Integration Systems

- C. The Metropolitan Board of Education
- D. The Office of the Criminal Court Clerk
- E. Health and Education Facilities Board
- F. County Clerk
- G. Department of Finance
- H. Department of Health
- I. Clerk and Master
- J. Circuit Court Clerk
- K. Juvenile Court Clerk
- L. Public Defender's Office
- M. Davidson County Sheriff's Office
- D-N. Register of Deeds

This Policy shall not apply to public entities that are affiliated with the Metropolitan Government but which constitute governmental entities in their own right, including but not limited to the Electric Power Board, the Metropolitan Transit Authority, the Convention Center Authority, the Metropolitan Nashville Airport Authority, the Metropolitan Development and Housing Agency, and the Emergency Communications District (the Other Governmental Entities). Other Governmental Entities that have Intergovernmental Agreements with the Metropolitan Government for the Metropolitan Government to provide to them support services such as through the Metropolitan Government Finance and Legal Departments (including but not limited to the Sports Authority, the Hospital Authority and the Industrial Development Board), may opt in to the Policy, subject to the approval of the Public Records Commission, and will be subject to all other provisions of this Policy applicable to a Metro Department which has not opted out.

- 5. Requests may be made to inspect public records or receive copies of public records pursuant to a process for same to be adopted by the Public Records Commission. The Public Records Request Coordinator may develop request forms consistent with the Public Records Commission's adopted rules and regulations. To the extent the use of such forms by requesters is to be required, the forms will be subsequently adopted by the Public Records Commission and incorporated into its rules and regulations.
- 6. Responses to public records requests shall be made in accordance with a process for same to be adopted by the Public Records Commission, which process shall include redaction processes.
- 7. Fees shall be charged for copies of public records in accordance with a statement regarding same to be adopted by the Public Records Commission, and billing and payment of such fees shall be handled in accordance with procedures to be adopted by the Public Records Commission.

8.	The Metropolitan Clerk is hereby designated to serve as the Public Records Request Coordinator of all Metro Departments who do not opt out of this Policy, pursuant to the procedures for same described above.

By applying a Neighborhood Conservation Overlay District on various properties along Eastdale Avenue, East Riverwood Drive, Eastdale Place, Riverwood Drive, and Plymouth Avenue, east of Gallatin Pike, zoned RS10 and RS20 (approximately 72.44 acres), being various parcels on various maps of the Official Property Identification Maps of The Metropolitan Government of Nashville and Davidson County, all of which is described by lines, words and figures on the attached sketch, which is attached to and made a part of this ordinance as though copied herein.

Section 2. Be it further enacted, that the Metropolitan Clerk is hereby authorized and directed, upon the enactment and approval of this ordinance, to cause the change to be on various maps of said Official Zoning Map for Metropolitan Nashville and Davidson County, as set out in Section 1 of this ordinance, and to make notation thereon of reference to the date of passage and approval of this amendatory ordinance.

Section 3. Be it further enacted, that this ordinance take effect immediately after its passage and such change be published in a newspaper of general circulation, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.



SUBSTITUTE ORDINANCE NO. BL2017-678

An ordinance to amend Title 17 of the Metropolitan Code of Laws, the Zoning Ordinance of The Metropolitan Government of Nashville and Davidson County, by changing from CN and RS5 to RM20-A, OR20, MUN-A, and MUL-A zoning for various properties along McFerrin Avenue, Seymour Avenue, and Cleveland Street and located within the Greenwood and Maxwell Heights Conservation Overlay Districts, (approximately 2.75 acres), all of which is described herein (Proposal No. 2016Z-075PR-001).

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That Title 17 of the Code of Laws of The Metropolitan Government of Nashville and Davidson County, is hereby amended by changing the Official Zoning Map for Metropolitan Nashville and Davidson County, which is made a part of Title 17 by reference, as follows:

By changing from CN and RS5 to RM20-A, OR20, MUN-A and MUL-A zoning for various properties along McFerrin Avenue, Seymour Avenue, and Cleveland Street, within the Greenwood and Maxwell Heights Conservation Overlay Districts (approximately 2.75 acres), being various parcels as designated on Map 082-08 of the Official Property Identification Maps of The Metropolitan Government of Nashville and Davidson County, all of which is described by lines, words and figures on the attached sketch, which is attached to and made a part of this ordinance as though copied herein.

Section 2. Be it further enacted, that the Metropolitan Clerk is hereby authorized and directed, upon the enactment and approval of this ordinance, to cause the change to be on Map 082 of said Official Zoning Map for Metropolitan Nashville and Davidson County, as set out in Section 1 of this ordinance, and to make notation thereon of reference to the date of passage and approval of this amendatory ordinance.

Section 3. Be it further enacted, that this ordinance take effect immediately after its passage and such change be published in a newspaper of general circulation, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.
