A resolution designating as park property the parcel to be acquired pursuant to Resolution No. 2019-1800.

WHEREAS, Resolution No. RS2019-1800, if approved, would authorize the acquisition of an approximately 106.8-acre tract (Metro Parcel ID No. 10200000500; the "Property") of real property in Bells Bend; and

WHEREAS, the Property should be used only for park, recreation, and open space purposes; and

WHEREAS, designating the Property for management, supervision and control by the Metropolitan Department of Parks and Recreation is in the best interest of Metropolitan Nashville and Davidson County.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. The Property is hereby designated for use as park, recreation, and open space purposes.

Section 2. The Property shall be managed, supervised, and controlled by the Metropolitan Department of Parks and Recreation.

Section 3. This resolution shall take effect from and after its adoption, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.

LATE-FILED ORDINANCE NO. BL2019-____

An ordinance amending Section 2.178.080 of the Metropolitan Code of Laws authorizing an increase in the assessment rate for the South Nashville Central Business Improvement District for Metropolitan Nashville and Davidson County, Tennessee.

WHEREAS, pursuant to the Central Business Improvement District Act of 1990, the District Management Corporation for the South Nashville Central Business Improvement District (the "District") has taken a vote to support an increase in the assessment rate for the District; and

WHEREAS, the property owners within the business improvement district in South Nashville, representing a majority of the real property owners and at least two-thirds of the assessed value of all real property within that area, have voted to increase the assessment rate for the South Nashville Central Business Improvement District (the "District"); and

WHEREAS, properly funding the South Nashville Central Business Improvement District will enhance the local business climate and help manage the area and ensure that it is properly redeveloped, safe, clean and vibrant and will bring more people to South Nashville to work, live, play, and shop; and

WHEREAS, proper funding for the District will facilitate the construction of a connector road network, other public improvements including water and sewer improvements and the construction of a public greenway, beautification efforts, business recruitment and retention and overall District promotions.

NOW, THEREFORE, BE IT ENACTED BY THE METROPOLITAN COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. Title 2 of the Metropolitan Code of Laws is hereby amended by deleting Section 2.178.080(B) in its entirety and substituting the following:

Section 2.178.080 Estimated Costs and Rate of Levy; Special Assessment Procedure.

- B. The rate of levy of the special assessment for the SONA CBID shall be increased, from the previously established rate, to \$1.00 per \$100 of assessed value of real property beginning in calendar year 2019. Such rate of levy shall continue in full force until changed by the metropolitan council in accordance herewith and no change shall occur if debt is secured with the special assessment revenue. A change in the rate of levy may be initiated only by a resolution of the district management corporation requesting that the rate be changed. Further, this rate must be approved in an election held by the district management corporation by not less than a majority in number of owners of real property in the district voting in said election. In addition, the assessed value of the property in the district owned by all of the persons voting affirmatively must equal or exceed at least two-thirds of the assessed value of the property in the district owned by all of the persons voting. Upon receipt of this resolution from the district management corporation, the metropolitan council must hold a public hearing on whether there should be a change in the rate of levy for the special assessment.

Section 2. This Ordinance shall take effect from and after its passage, the welfare of the Metropolitan Government of Nashville and Davidson County requiring it.

Mr. President –

I move to amend Ordinance No. BL2019-1633, as substituted, as follows:

I. By adding the following recitals clauses:

WHEREAS, in 2018, the Tennessee General Assembly adopted the Short Term Rental Unit Act, now codified at Tenn. Code Ann. §13-7-601, et seq., which created inconsistencies with existing short term rental property regulations under the Metropolitan Code of Laws, necessitating revisions included below.

WHEREAS, the web-based platform marketing of non-owner occupied short-term rental properties has emerged unexpectedly within recent years in Nashville and Davidson County and elsewhere. This transformative and disruptive development posed significant challenges to the Metropolitan Government’s longstanding zoning and land use regulations. As evidenced by multiple legislative initiatives, the Metropolitan Council -- like local legislative bodies across the United States -- has struggled to craft an appropriate regulatory environment. Many relied upon initial regulatory frameworks established by the Metropolitan Government, including specifically those who acquired interests in and invested in RM-zoned property for purposes of developing short term rental units. To the extent this regulatory framework has proven unsustainable and requires reform, equity and fairness requires that those who relied in good faith upon previous regulations be provided limited exemptions from ordinances that eliminate prior permitted uses. In so doing, the Metropolitan Government does not establish, enable, or intend to encourage any additional exemptions to others not similarly situated.

NOW, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. Subsection 17.40.720.A of the Metropolitan Code of Laws is hereby amended by deleting the reference to "600" within the chart thereof and substituting in lieu thereof: "1,000". subsection in its entirety and substituting therefore the following:

- A. No public hearing shall be conducted unless, at least twenty-one days prior to the public hearing, the owner(s) of the subject property and all other property owners within one thousand (1,000) feet of the subject property have been given notice of the time, date and place of the public hearing. Properties owned by the applicant shall not be included in the distance measurement for public notice. For a public hearing conducted by the board of zoning appeals, the appellant shall be notified by certified mail. In addition to notification of individual property owners, an incorporated condominium association registered with the metropolitan clerk as requesting notification shall also be notified. The provisions of this article shall not apply to the adoption or subsequent amendment of this title, or to amendments of the official zoning map involving floodplain or airport overlay districts.

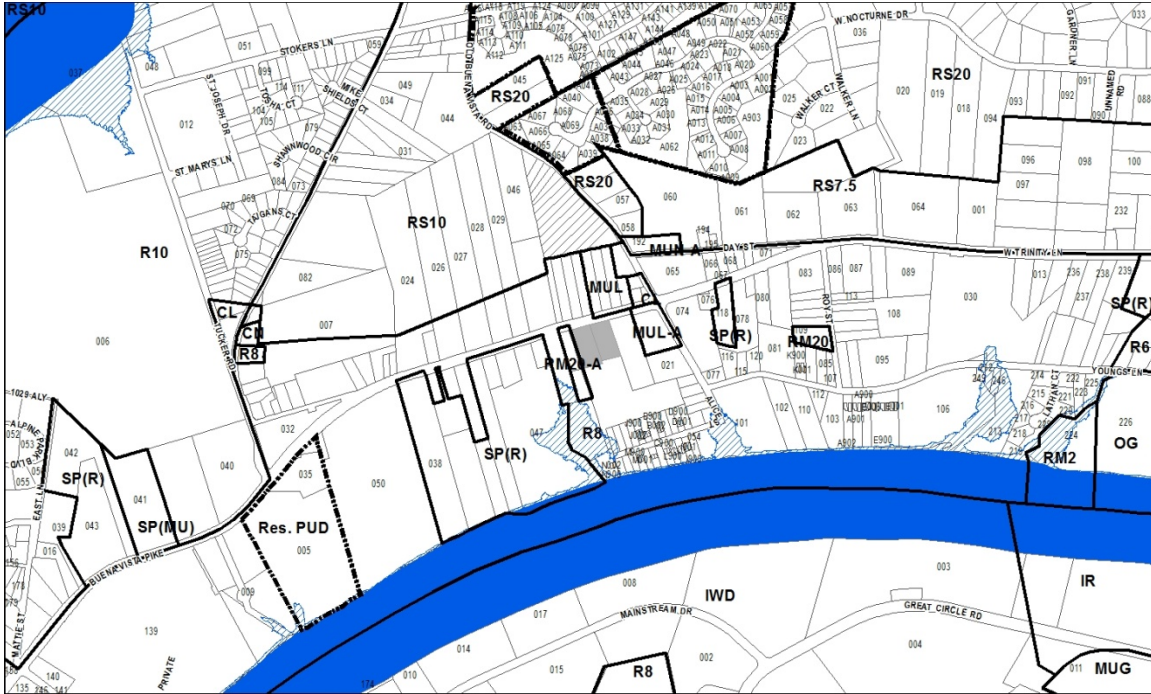

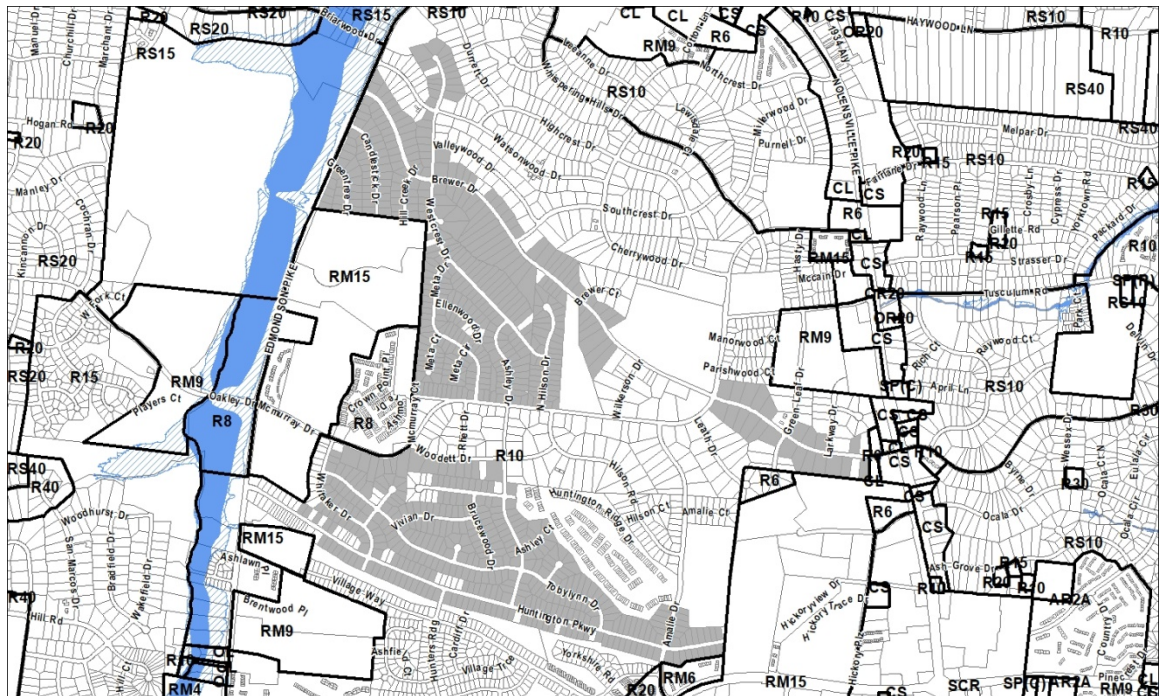

SUBSTITUTE ORDINANCE NO. BL2019-1706

An Ordinance Banning the Use of Action Devices on Tennessee Walking Horses, Racking Horses, and Spotted Saddle Horses.

WHEREAS, historically, Tennessee Walking Horses, Racking Horses, and Spotted Saddle Horses have been subjected to soring, a practice which involves the intentional infliction of pain to a horse's legs or hooves in order to force the horse to perform an artificial, exaggerated gait; and

WHEREAS, the abuse of horses through soring techniques has been documented extensively through undercover investigations by organizations such as the Humane Society of the United States, and is particularly prevalent in the state of Tennessee, where many Tennessee Walking Horses, Racking Horses, and Spotted Saddle horses are shown and exhibited; and

WHEREAS, a recent World Grand Champion of the Tennessee Walking Horse National Celebration, held in Tennessee, was found to be sore; and

WHEREAS, at the 2013 Tennessee Walking Horse National Celebration, USDA testing showed that 67% of the horses tested positive for substances that could be used to hide soring; and

WHEREAS, numerous horse exhibitions showcasing Tennessee Walking Horses, Racking Horses, and Spotted Saddle Horses have historically taken place in the City of Nashville; and

WHEREAS, trainers and exhibitors who do not sore their horses suffer a competitive disadvantage against those that do so illegally, and this creates unfair competition by deceiving the spectating public and horse buyers; and

WHEREAS, action devices such as chains, collars, rollers, beads, pads, wedges, and weighted shoes are integral to the soring process and are intended to inflict pain upon the horse; and

WHEREAS, current Federal laws do not properly address the use of such action devices on horses; and

WHEREAS, the horse industry currently is able to train their own inspectors in what the USDA says is a conflict of interest that leaves them with no incentive to find violations; and

WHEREAS, during audits, federal inspectors consistently find more sored horse than private inspectors do; and

WHEREAS, Metro Animal Care and Control (MACC) is committed to the delivery of humane and responsive animal care and control services to and for the residents and animals of Nashville-Davidson County; and

WHEREAS, MACC is committed to the prevention of animal cruelty and the enforcement of anti-cruelty laws. Animal cruelty is defined as behaviors that cause unnecessary pain, suffering, distress, and/or the death of the animal; and

WHEREAS, MACC works closely with local authorities to document, collect, and preserve evidence for further evaluation and prosecution; and

WHEREAS, the Metropolitan Government of Nashville believes it is in the best interests of this City to adopt reasonable regulations to prevent cruelty to horses, promote the welfare and humane treatment of animals in the City, ensure fair competition in horse shows and exhibitions, and foster a more humane environment in the City.

NOW, THEREFORE, BE IT ENACTED BY THE COUNCIL OF THE METROPOLITAN GOVERNMENT OF NASHVILLE AND DAVIDSON COUNTY:

Section 1. That Chapter 8.12 of the Metropolitan Code of Laws is hereby amended by creating a new Section 8.12.120 as follows:

8.12.120 – Prohibition on Use of Action Devices on Horses

A. Definitions.

1. The term "action device" means any boot, collar, chain, roller, or other device that encircles or is placed upon the lower extremity of the leg of a horse in such a manner that device:
 - a. Rotates around the leg or slides up and down the leg; or
 - b. Touches or strikes the hoof, coronet band, fetlock joint, or pastern of the horse.
 2. The term "action device" does not include soft rubber or soft leather bell boots or quarter boots that are used as protective devices.
 3. The term "participant" means anyone engaging in any activity with respect to a horse show, horse exhibition, or horse sale or auction, including, but not limited to, the following:
 - a. Transporting or arranging for transportation of a horse to or from a horse show, horse exhibition, or horse sale or auction;
 - b. Personally giving instructions to an exhibitor; or
 - c. Knowingly entering or remaining in a warm-up area, inspection area, or other area at a horse show, horse exhibition, or horse sale or auction that spectators are not permitted to enter.
- B. Prohibited Conduct. It shall be unlawful and considered animal abuse for any trainer, exhibitor, owner, rider, or participant to use a weighted shoe, pad, wedge, hoof band, or other action device at a horse show, horse exhibition, or horse sale or auction that—
1. Is placed on, inserted in, or attached to any limb of a Tennessee Walking Horse, a Racking Horse, or a Spotted Saddle Horse; and
 2. Is not strictly protective or could reasonably be expected to cause physical pain, distress, or inflammation; and
 3. Is not solely therapeutic in nature; and under the supervision of a person licensed to practice veterinary medicine in the state in which such treatment was given within the context of a veterinary client-patient relationship.
- C. No horse shows, horse exhibitions, or horse sales or auctions shall be held without an USDA employed inspector or USDA employed Veterinary Medical Officers on site to inspect horses for soring. This does not include Designated Qualified Person (DQP) individuals.
- D. Civil Penalty. Any person who violates the provisions of subsection B or C shall, upon conviction thereof, be fined \$50. Each violation of subsection B shall constitute a separate violation.
- E. Any participant convicted under subsection D shall not be allowed to participate in future horse shows, horse exhibitions, or horse sales or auctions.

Section 2. If any section, subsection, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance which shall continue in full force and effect, and to this end the provisions of this Ordinance are hereby declared to be severable.

Section 3. This Ordinance shall take effect from and after its passage, the welfare of The Metropolitan Government of Nashville and Davidson County requiring it.
