Early voting for the March 18, 2014, City of Berry Hill Municipal Election will be held at the **satellite location** of the Davidson County Election Commission Office located at **800 2nd Avenue South, 4th Floor**, Nashville, Tennessee. The dates and hours for early voting are as follows:

February 26, 2014 through March 13, 2014
Monday through Friday-- 8:00 a.m. to 4:30 p.m.

The polling location on Election Day, March 18, 2014, is the Berry Hill City Hall, which is at located at 698 Thompson Lane, Nashville, Tennessee. The poll will be open from 7:00 a.m. to 7:00 p.m.

Name and address changes or other registration record modifications must be made at or received by the Davidson County Election Commission by 4:30 p.m. on Thursday, March 13, 2014.

EMERGENCY VOTING: Persons entering a hospital between Wednesday, February 26, 2014, and the morning of Tuesday, March 18, 2014, and who are unable to vote in person on election day, should call the office of the Davidson County Election Commission at (615) 862-8815 for emergency Absentee Voting Registrars to provide ballots and voting assistance. The call must be received at the commission office no later than 7:00 a.m., on **Tuesday, March 18, 2014**. (Election Day) See T.C.A. 2-6-401c.

An eligible voter may be able to vote absentee by personal appearance at the Commission Office during the period of March 13, 2014 to March 17, 2014, under the following circumstances:


- 1. Due to the death of a relative of a voter which would result in the voter's absence from the county on Election Day;**
- 2. If the voter receives a subpoena or services of process requiring the voter's presence on Election Day.**

To vote as stated above, the voter shall show reasonable proof to the Administrator of Elections or his Deputy. The above two categories are in addition to those persons or categories of persons otherwise authorized to vote absentee as set forth in T.C.A. 2-6-101 et. seq.
