PROTECT CIVIL RIGHTS

- The mission of the FBI's Civil Rights Program is to enforce federal civil rights statutes and to ensure that the protected rights of all persons are not abridged.
 - HATE CRIMES Criminal offense motivated by bias against persons or property based on:
 - RACE
 - RELIGION
 - ETHNICITY / NATIONAL ORIGIN
 - DISABILITY
 - SEXUAL ORIENTATION
 - COLOR OF LAW Official actions taken by person (s) acting under the authority of local, state or federal laws to willfully deprive someone of a right or privilege or immunities secured or protected by the constitution or laws of the US
 - HUMAN TRAFFICKING
 - Freedom of Access to Clinic Entrances (FACE) Act
 Protects reproductive health providers, patients FBI has exclusive jurisdiction.

Offensive speech or act that doesn't break a law (1st Amendment Right)





Man in Hate-Mail Case Given Probation and Fine

ANTA ANA, Calif. -- The man who was convicted in the nation's first federal trial involving a hate crime on the Internet was sentenced Monday to a year of probation and a \$1,000 fine, although the prosecutors' request that he stay off the Internet during probation was de

The man, Richard Machado, had already served a year in jail, the maximum term for his crime. The 21year-old Los Angeles man was convicted in February of violating the civil rights of Asian university students to whom he had sent threatening e-mail. He had sent a nine-line, profanity-filled e-mail message to 59 students with Asian-sounding names in September 1996 at the University of California at Irvine. The message said, in part, "I personally will make it my life carreer [sic] to find and kill everyone of you personally." It was signed, "Asian Hater."

Because he fled to Mexico after his indictment in November 1996, Machado spent a year in Federal custody after his arrest a few months later. Further terms of his sentencing in federal District Court were that he refrain from taking illegal drugs and submit to drug testing, that he undergo psychiatric counseling, with participation in a racial tolerance program as a component in that counseling, that he not set foot on the Irvine campus and that he not try to contact any of the recipients of the threatening e-mail message or anyone who testified at the trial.

Defense lawyers said they would appeal Machado's conviction.





Lawrence Russell Brewer, 44, is scheduled to die Wednesday by lethal injection in the killing of James Byrd. (CNN) -- Lawrence Russell Brewer was executed in Texas Wednesday evening for his involvement in the infamous dragging death of a black man 13 years ago.

Brewer, 44, was one of three men convicted for involvement in the murder of James Byrd.

He was executed by lethal injection at 6:21 p.m. local time (7:21 p.m. ET) Wednesday, according to the Texas Department of Criminal Justice.

Arson destroys Maury mosque

Building spray-painted with swastikas, slogans

COLUMBIA, Tenn. - A mosque belonging to a small Muslim community in Columbia was spray-painted with swastikas and then destroyed by flames early Saturday morning.

Columbia Police Chief Barry Crotzer said one of his officers had driven by the mosque around 3 a.m. Saturday and had seen nothing out of the ordinary. But when firefighters arrived at the Islamic Center of Columbia around 5:30 a.m., they found it ablaze and discovered hate slogans on the side of the building.

"One said, 'White Power,' the other said, 'We run the world,' " said Randy Thysse, assistant special agent in charge of the Memphis office of the FBI.

Agents from the FBI and the Department of Alcohol, Tobacco, Firearms and Explosives are working with local police and fire departments to investigate the fire.

"It looks pretty obvious that it was arson," said Jim Cavanaugh of the ATF. Cavanaugh said investigators would continue working today to confirm the fire as arson.

Mosque fire could bring ----hate crime charges for 3

COLUMBIA — Three Columbia men could face federal hate crime charges after police say they painted swastikas and phrases such as "white power" on a mosque then set it on fire.

Investigators believe the fire at the Islamic Center of Columbia started around 5 a.m. Saturday.

Later that night authorities arrested Jonathan Stone, 19, every Muslim when they see a Michael Golden, 23. and Eric swastika painted on the side of a Baker, 32, according to Jim Cavanaugh, special agent in charge of the Nashville office of

the Bureau of Alcohol, Tobacco, Firearms and Explosives. Authorities did not say how they tracked down the suspects.

"It affects every American and mosque destroyed by arson," Cavanaugh said Sunday.

The men are being held in the

Maury County Jail and face possible federal charges for attacking a house of worship and other federal crimes, he said.

Shocked by reports of the arson and hate slogans, Pastor Randy Miller chose to pray about the matter Sunday morning with his congregation at Trinity Lutheran Church in Columbia.

"You think that these walls were broken down a long time ago," Miller explained later, "but they still exist today. "God created all of us, so respect

for someone else's faith, tradition and building should exist."

The small mosque, located in a former electronics repair shop on Main Street, serves as a place of worship for the few Muslim families in Maury County.

"This is a level of hatred our community doesn't need," said the Rev. Pete Tackett, senior pastor of



State prosecutors are also awaiting indictments from the Maury County grand jury for arson of a place of worship. The three men were given a preliminary hearing Feb. 25 before Judge Lee Bailey.

The defendants could receive a maximum sentence of 20 years imprisonment if convicted for destroying a house of worship by using an explosive device, according to U.S. Code.






