Standard department procedure during intake requires informed questions to be asked of everyone regardless of ethnicity. Demographic information is collected during the arrest process with Metro Nashville Police Department and is then inputted in the database. The resident's information is transferred from MNPD's database to the Court Clerk's database known as CJIS. Once an individual is placed on supervised probation, that information is then downloaded into our database "ADPB" or Adult Probation. Shared information such as: Address, Phone Number, Date of Birth, and Social Security Number is transferred. Once in the intake process, additional information is gathered such as: employment and references. ADPB is a software that was created in the early 2000's.

This process has been in existence for numerous years with the shared databases of collective information. Justice Integration Services oversees the software for General Sessions Court Probation.

Federal student privacy law (FERPA), the Equal Protection Clause of the United States Constitution (see *Plyler v. Doe*), and the guidance from the Tennessee Department of Education

1. This is the short version of what we have shared with districts a couple times over the past year:

The U.S. Supreme Court held in in 1982 in the case of *Plyler v. Doe* that a state may not deny access to public education to any child, regardless of the student's citizenship or immigration status. Temessee does not collect data on the immigration status of students. It is not the role of school officials to determine the legal status of students and their families. Additionally, school officials must remember that student records are protected as confidential under the Family Educational Rights and Privacy Act (FERPA), which restricts the disclosure of student records.

2. Around the time of the ICE raids in east TN, we were asked about how districts should handle ICE, and this is what we shared:

ICE is a federal immigration agency that has the legal authority to enforce immigration law. To ensure compliance with all laws, school districts are encouraged to set a protocol that all inquiries from federal agencies, such as ICE, requesting access to students or student records be directed to the director of schools who should consult with the local board attorney about the proper response.

3. And finally, this is our longer response, which is what I've shared with reporters (a few more now today have asked after yesterday's story) and we have shared it with districts, too:

Federal law – from Plyler v. Doe – says that no student can be denied a public education because of his or her citizenship or immigration status, and students and their parents cannot be required to share information about their immigration status. We have shared with our districts that it is not the role of school officials to determine the legal status of students and their families. Further, we have provided this guidance to our schools in this context of supporting our English learners (it is within our ESL Manual):

- Schools are prohibited from providing any outside agency—including the Immigration and Naturalization
  Service—with any information from a student's school file that would expose their undocumented status
  without first obtaining permission from the student's parents. The only exception is if a court order
  (subpoena) is served; however, parents may challenge such an order; (this is due to FERPA, the federal
  privacy law) and
- School personnel—especially building principals and those involved with student intake activities—should be aware that they have no legal obligation to enforce U.S. immigration laws.

Additionally, federal civil rights laws prohibit districts and schools from asking questions that could have a "chilling" effect or prohibit students from attending school.

Finally, section 6 of the law in question notes that it can only be implemented in a manner consistent with federal laws and protecting the civil rights of all persons, and it also notes that any part of the act that would be in conflict or inconsistent with federal law shall be superseded by the applicable laws.

    - The Metro Public Health Department issues birth and death certificates and collects a great deal of personal information in its various clinics. Our guiding principles regarding the release of this information are the federal HIPAA privacy guidelines (which define `protected health information' covered by the Act) and the Tennessee Open Records Act. The state provides guidelines on who is eligible to get a copy of a death certificate or a birth certificate for someone besides themselves. If any individual does not fall within those guidelines we would require a court subpoena before providing it.

The MNPD collects a variety of information from victims of crime, suspects of crime and persons related to the investigation of crime. Often, an essential element of our duties involves the verification of identity for a person. Name, date of birth, place of birth, and social security number are all essential to that function. The MNPD complies with applicable state law in disseminating public records. To the extent permitted by law (TCA 10-7-504(a)(29)), personal identifying information is redacted prior to public release.

The MNPD has no authority to enforce or investigate immigration offenses. Immigration status is irrelevant to the MNPD in carrying out our duties.

The MNPD, along with the Office of District Attorney, occasionally processes U-Visa's for immigrants who self-report their immigration status; most often when they are a victim of a crime. This form is used for immigrants, who due to their status, may otherwise be eligible for removal by the federal government. The processing of this U-Visa allows them to remain in order to assist in the prosecution of the case.

By charter and policy, the MNPD responds to calls for police service from anyone within the county. If the request is within the scope of MNPD duties, the MNPD

has no discretion to not respond. Requests for non-emergency mutual aid assistance would require approval of the Chief of Police, or designee.

Yes, on July 22, 2019 MNPD assistance was requested by immigration officers to respond to an address in Hermitage TN. Having unclear information about the request, MNPD responded. After determining that no emergency existed, that there was no imminent threat to life of property, and having no legal authority to investigate or enforce immigration issues, the MNPD, consistent with policy, did not involve itself in the federal matter. As a crowd developed, MNPD officers did stay in the area to monitor the situation.

Yes. Requests for non-emergency assistance would require approval of the Chief of Police, or designee. Having received no official request and lacking jurisdiction, the MNPD did not involve itself in the federal matter.
