## News from the Chief



In a May 21 email we announced that the Director of Finance, Rich Riebeling, appeared before the Civil Service Commission and recommended that incremental pay raises commence, as scheduled, on July 1, 2013, and that a one and one half percent raise for all employees take effect on January 1, 2014. The Commission approved this proposal. The Metropolitan Council approved both the incremental pay raises and the one and one half per cent raise as a part of the Fiscal Year 2013-2014 Metropolitan Government budget.

Incremental pay raises will commence, as scheduled, on July 1, 2013, for all employees eligible to receive increments.

Immediately following the approval of the increment raises, FOP President Robert Weaver initiated a discussion concerning pay increases for employees in Open Range classifications. A review of our HR records indicated that there had been no Open Range pay increases for MNPD employees since 2006. An analysis conducted by the MNPD Fiscal staff indicates that, with careful budget management, a 3 percent Open Range increase could be awarded those eligible employees.

After discussions with Mayor Dean and his staff, this plan has been approved. Therefore, pursuant to Civil Service Policy 5.10-II, eligible employees in the applicable classifications will receive a 3 percent Open Range pay increase. And, as has been stated previously, on January 1, 2014, all employees will receive a one and one half percent pay increase in addition to any increment or Open Range pay increase.

To restate what we said in the May 21 email:

We will have to institute cost saving measures to ensure that funds are available to implement these raises. That said, I assure you that these measures will NOT include employee layoffs or furloughs of any type. The funding to support these pay increases will come from various areas within the MNPD budget, but most notably from attrition and delaying the filling of vacancies.

Although this will be difficult as we go forward, I fully support this plan. Our employees are dedicated and work hard. They deserve to be compensated for that dedication and work.

Each year, for the past several years, we have enhanced our level of service to this community. Our goal for the coming fiscal year will be to build on our successes and deliver yet another year of increased/improved service to citizens, albeit with less resources. Working together, we can and will do this.

Regardless of where you work in this department, you are a valued and important part of our mission to reduce crime and improve quality of life for Nashvillians and our visitors. Your individual contribution is critical to our success. I sincerely thank you all for your continuing dedication and commitment to excellence.

### The Precinct News

A tip to Crime Stoppers led to the arrest of suspected serial burglar Jovany Garces who is believed responsible for at least 10 business break-ins in the Nashville area since the first of the year.

The Crime Stoppers tip came after the police department released surveillance images of the man who broke into Sally Beauty Supply at 55 E. Thompson Lane on June 6<sup>th</sup> and stole the safe. Through further investigation, including an analysis of evidence found at the scene of a burglary at Twin Kegs Bar at 413 Thompson Lane that directly linked Garces to that case, an arrest warrant was issued. South Precinct detectives and officers arrested Garces at his Linbar Drive apartment after finding him hiding inside a child's closet. A safe from one of the burglaries was found in the apartment's master bedroom. Garces was taken to General Hospital for treatment of an arm laceration apparently received in the Twin Kegs break-in and then to jail.

Additional warrants were issued charging Garces with the June 4<sup>th</sup> burglary of the same Twin Kegs location and the June 6<sup>th</sup> burglary of Sally Beauty Supply at 55 E. Thompson Lane. Detectives believe Garces is also connected to the following burglaries:

- Daniela's Bar at 12 E. Thompson Lane on January 4<sup>th</sup> and June 3<sup>rd</sup>;
- Bikini Beach Bar at 1297 Antioch Pike on June 5<sup>th</sup>;
- Sally Beauty Supply at 3143 Lebanon Pike on June 6<sup>th</sup>;
- Sally Beauty Supply at 78 White Bridge Road on June 8<sup>th</sup>;
- Sally Beauty Supply at 5320 Mt. View Road on June 9<sup>th</sup>; and
- Sally Beauty Supply at 4414 Lebanon Pike on June 10<sup>th</sup>.

During an interview with Garces' wife, Janitzia Amor, 37, detectives learned that she drove him to at least some of the burglary locations. She was also arrested on three counts of burglary facilitation.

Investigation by South Precinct undercover detectives regarding the possible manufacture of methamphetamine at 1505 Celebration Way led to the arrest of four persons and the seizure of items commonly used to make meth.

Recovered during the execution of a search warrant were three one-pot cooking vessels with associated residue, a bottle of drain cleaner (lye), a plastic cup containing an acid and a glass tube containing an organic solvent.

The four residents, Nicole Sherman, 20; Rachel Goldzweig, 29; Tebetha Greathouse, 44; and James A. Hall, 54, are each charged with three counts of initiating the process to manufacture methamphetamine and possession of drug paraphernalia.

South Precinct detectives were assisted in the execution of the search warrant by Narcotics Unit officers and members of the Tennessee Methamphetamine Task Force.

A Crime Stoppers tip led to the arrest of suspected serial vehicle burglar Tremale Wilson, 28, at a residence in the 4100 block of Ames Drive. He is now charged with the following three break-ins (all occurred at parks):

- June 4<sup>th</sup> the victim parked her car at Centennial Park, 2500 West End Avenue. When she returned an hour later, her purse was taken from under the driver's seat.
- May 25<sup>th</sup> the victim parked her car at the Beaman Park trail head, 5911 Old Hickory Boulevard, to go walking at 10 a.m. When she returned her purse was missing from the rear passenger floor board.
- May 28<sup>th</sup> the victim parked his car at Beaman Park, 4111 Little Marrowbone Road, to go jogging at 1:45 p.m. When he returned his wallet, which had been placed in a pants pocket in the back seat, was taken.

In all three cases, a window was broken to gain access. Wilson was also identified as the man who later used the victims' credit cards to purchase electronics and clothing.

Wilson had been free on \$5,500 bond stemming from his June 7<sup>th</sup> arrest for allegedly breaking into a woman's car at Percy Warner Park last month. The victim discovered her purse was missing from her vehicle when she returned.

Wilson is now charged with three counts of burglary of a motor vehicle, six counts of forgery and six counts of fraudulent use of a credit card. Wilson, who has previous convictions for attempted aggravated kidnapping, domestic assault and drug possession, is being held in lieu of \$57,000 bond.

Convicted felon Jimmy Ray Ferrell, 34, was charged with aggravated robbery for the June 12<sup>th</sup> hold-up of a cab driver.

The victim reported that he picked up the suspect in the 1300 block of Jones Avenue (where Ferrell resides) and transported him to 2400 Buena Vista Pike. Before the suspect got out of the cab he held a knife to the driver's neck and demanded his belongings. The robber fled on foot with the cabbie's cash and wallet.

Ferrell was identified as a suspect after video footage from a camera inside the cab was aired by the media.

Ferrell is being held in lieu of \$80,000 bond. He has previous convictions for assault, felon in possession of a handgun, felony drug possession, resisting arrest, evading arrest, DUI, and theft.

West Precinct Officer Michael Lynch alertly spotted burglary suspect Larry Groves, 19, walking on 9<sup>th</sup> Avenue South near Olympic Street.

Warrants had been issued earlier this year charging Groves with the following break-ins:

- February 17 at Page Duke Landscape Architects, 1206 17<sup>th</sup> Avenue South;
- January 8 and December 10, 2012 at Creative Soul Music Academy, 1026 16<sup>th</sup> Avenue South.

Groves, who did not have any identification, initially gave Officer Lynch a false name. He is charged with three counts of burglary and criminal impersonation. Groves, of Hillside Avenue, remains jailed in lieu of \$40,000 bond.

A Crime Stoppers tip led to the apprehension in Memphis of murder suspect Santerius Lavender, 24, who was wanted for the April 9<sup>th</sup> fatal shooting of Chad Allen Daniel on Hillside Avenue.

Investigation by West Precinct detectives shows that Daniel, 33, was shot while in the front passenger seat of a Nissan Altima that had been driven to apartments at 1330 Hillside Avenue by his 26-year-old friend, who had arranged to make a drug buy from Lavender's girlfriend, Bershia Edens. The 26-year-old reported that as he approached Edens in a breezeway, a gunman, alleged to have been Lavender, appeared and demanded money. The 26-year-old said he threw down his wallet and ran back to the Altima as the gunman followed. He said that as he tried to pull away, shots were fired into the car and Daniel was struck. The 26-year-old then drove to Wedgewood Avenue, where he noticed a police officer working a traffic assignment at Wedgewood & Beech. He pulled over there and asked for help. Daniel was already dead.

Edens, 24, of 1330 Hillside Avenue, was jailed May 31<sup>st</sup> on a Davidson County Grand Jury indictment charging her with first-degree murder, especially aggravated robbery and aggravated robbery. Lavender, who is being returned to Nashville from Memphis, faces the same charges.
