## News from the Chief



It is with great pleasure and full confidence in her skills and abilities that I today formally announce the addition of veteran Davidson County Assistant District Attorney General Kathy Morante as Director of our police department's Office of Professional Accountability effective November 1st. Many of you have worked with Kathy during her 14-year tenure with the District Attorney's Office. She has prepared indictments, consulted with homicide and sex crimes detectives on investigations, and has been the prosecutor in a wide range of

felony cases, including approximately 30 murder cases. In addition, Kathy has served as the team leader in three separate divisions of Criminal Court and handled the prosecution of violent teenagers in Juvenile Court. Prior to joining the District Attorney's Office, Kathy was a Deputy Attorney General for the State of Tennessee. Kathy is a graduate of Vanderbilt University Law School and the University of Michigan.

We are very fortunate to have a person of Kathy's integrity and knowledge, not only of the law, but of Nashville and this police department, to head the Office of Professional Accountability. More than 100 persons from across the country submitted applications for the OPA position, although not all were qualified. From those applicants, 24 were selected to appear before an interview panel comprised of volunteer Nashville community leaders John Seigenthaler, Maria Toro, Tom Negri, Hedi Weinberg and Vanderbilt Police Chief August Washington. The top 6 persons from those interviews appeared at a later time before a second panel consisting of Deputy Chiefs Henry, Huggins and Johnson, and Ms. Sue Bibb from Police Human Resources (I sat in on those six interviews as an observer). In the end, Kathy was the unanimous number 1 choice.

Presently, Kathy is involved with a number of cases at the District Attorney's Office, including the Vanderbilt University rape case. She anticipates being able to start with us on November 1st.

Captain Preston Brandimore, who has served as interim OPA Director for the past 12 months, and Commander Terrence Graves, who served as interim OPA Director for 6 months prior to that, both while also leading the Criminal Investigations Division, have done excellent work while also enhancing OPA's operations and professionalism. I am deeply appreciative to them both. Preston will assist in acclimating Kathy to her new role in the days after her arrival here.

Thank you all for welcoming Kathy to the Metropolitan Police Department. Thank you, as well, for everything you do to make Nashville safer for our city's families and visitors.

## **Traffic Officers Recognized at Annual Conference**

On September 5<sup>th</sup>, members of the MNPD Traffic Section attended the Tennessee Annual Lifesavers Conference in Murfreesboro, Tennessee. During the awards presentation our department was recognized both locally and nationally for the following achievements:

- 1) 1<sup>st</sup> place in the state of Tennessee for the GHSO Chief's Challenge
- 2) 1<sup>st</sup> place nationally for the GHSO Chief's Challenge
- 3) Special Category Award for our department's motorcycle safety program and initiatives

In addition to the above awards for the department, the following officers received the "MADD Hero Award" for making over 200 DUI arrests with a minimum of a 75% conviction rate:

#### The Precinct News

#### **Hermitage**

Parolee Lawrence Hampton, 25, is charged with attempted criminal homicide for allegedly shooting a 17-year-old male victim Wednesday evening after the two apparently argued earlier in the day during a basketball game.

Witnesses reported that Hampton approached the teen armed with a shotgun and fired as the victim stood in the 4400 block of Gina Brooke Drive. The teen was struck in the hand. Before fleeing in a silver mini-van, Hampton was seen reaching towards a window of a nearby residence. Hermitage Precinct officers later stopped the mini-van in the 5700 block of Old Hickory Boulevard where Hampton was taken into custody. A shotgun was recovered from the nearby residence where Hampton was seen prior to leaving in the mini-van.

The victim was transported to Vanderbilt University Medical Center where he was treated for a non-life threatening injury. Two other teen victims reported being struck by shrapnel but refused medical attention.

In 2008, Hampton received an eight year sentence for aggravated robbery concurrent with a six year sentence for robbery. He remains jailed in lieu of \$350,000 bond.

Outstanding police work coupled with citizen assistance led to the apprehension of two men charged with an armed robbery.

Ryan Pittman, 28, approached a man who was sitting in his parked van outside the Comfort Suites at 2615 Elm Hill Pike. Pittman demanded his wallet while pointing a short barreled shotgun at the victim's stomach. The victim complied, but then Pittman noticed there was no cash in the wallet and ordered the victim to move to the passenger side of his vehicle so Pittman could drive him to an ATM. The victim grabbed the barrel of the shotgun, and with assistance from another citizen, subdued Pittman until police arrived. Witnesses reported that Pittman's alleged accomplice, Blake Bartelson, 29, fled the scene. He was quickly identified and later taken into custody.

Pittman, of Seven Mile Court, admitted his involvement in the hold-up. He is charged with aggravated robbery, attempted kidnapping and attempted carjacking. Pittman has previous convictions for theft and DUI. Bartelson, of Tara Ann Court, is charged with aggravated robbery. He has felony cocaine convictions in Williamson and Davidson Counties.

Brandon Starks, 21, is charged with aggravated assault after an apparent drug-related shooting on the corner of Lewis Street and Robertson Avenue.

Starks allegedly fired several shots into the ground near the female adult victim's feet after the pair argued. She was struck in the leg by a ricochet. Starks fled on foot. Officers located him on Wharf Avenue where he was taken into custody without incident. The victim was treated for non-life threatening injuries.

Starks has previous convictions for drug possession and evading arrest.

Hermitage Precinct on September 17<sup>th</sup> hosted "Coffee with a Cop" from 9 a.m. – 10:30 a.m. at Starbucks, 5008 Old Hickory Boulevard.

Twelve citizens dropped by to discuss issues and concerns. Starbucks sponsored the event and provided attendees with a free cup of house blend coffee.

#### **South**

Murder suspect Erick Tenaz, 21, Thursday surrendered himself at the Metropolitan Justice Center and is presently jailed in lieu of \$200,000 bond for his alleged participation in the September 8<sup>th</sup> shooting death of Shivon Burhan Abdullatif outside Club Cielo in South Nashville.

South Precinct detectives arrested Erick's brother, Issac Tenaz, 23, on a murder charge Wednesday afternoon. He remains in jail.

Additional arrests in this case are anticipated.

Numerous hours of intense investigation by Detectives Danny Warren, Chad High and Corey Wall revealed that the Tenaz brothers were two of several individuals inside a black Honda from which shots were fired as they left the area of Club Cielo in the early morning hours of September 8<sup>th</sup>. Detectives believe the persons in the Honda had been involved in a fight outside the establishment. Abdullatif, 21, of South Nashville, is not thought to have been involved in the fight, but rather was standing near one of the participants when the rounds were fired. Abdullatif died shortly after arriving at Vanderbilt University Medical Center.

Issac Tenaz was convicted on two felony marijuana charges in 2012. His sentences, which totaled three years, were suspended and he was placed on probation.

South Precinct detectives charged five persons with murder in connection with the August 31<sup>st</sup> shooting death of Anastacio Lopez Taperia, 21, who was fatally wounded shortly after midnight in the parking lot of a Packard Drive apartment complex during an apparent planned robbery attempt.

Jailed are:

•Candice Young, 23, of Antioch;

•Robin Griggs, 33, of Smyrna;

•Derek Lance, 29, of Smyrna;

•Stanley Hawkins, 26, of Clarksville; and

•Ronnie Palmer, 32, of Nashville.

Officers were called to the parking lot of 860 Murfreesboro Pike at 12:50 a.m. by a friend of Taperia's who was with him when he was shot and drove him from the scene. Taperia was dead inside the car.

During the investigation led by Detectives Chad High and Bill Stewart, it was learned that Taperia and two friends had been at a bar on Apache Trail, where they met two women (Young & Griggs). As the parties left the bar, the three men followed Young & Griggs to Horizon Park Apartments at 4601 Packard Drive. When the three men got out of their car at the apartment complex, defendants Lance, Hawkins and Palmer are alleged to have appeared from the shadows to rob the victims. During the robbery, Taperia was fatally shot, allegedly by Lance. Taperia was then driven away by his friends.

Detectives believe that the five defendants had preplanned the robbery scenario, with the two women meeting potential victims at a Hispanic bar and luring them to the Packard Drive apartment complex where the others would suddenly confront them.

Outstanding police work by Lieutenant Curtis Watkins led to the apprehension of the five suspects. Watkins, who was serving as the police department's overnight field supervisor, was leaving the Murfreesboro Pike parking lot where Taperia's body was found when he spotted a red Dodge with a temp tag that matched the description of the suspect car provided by Taperia's friends. Watkins followed the Dodge to Patricia Drive where he initiated a traffic stop. All five defendants were inside. One of Taperia's friends identified them as being involved in the homicide.

Lance is being held in lieu of \$2 million bond. The other four defendants are being held in lieu of \$1.5 million bond each.

Acting on a citizen's tip, South Precinct undercover detectives arrested a suspected local drug dealer after he picked up a 35 pound shipment of marijuana sent here from California.

Abdifatah Adan, 30, is jailed in lieu of \$35,000 bond on a felony marijuana charge.

Adan was seen picking up a parcel at a Linbar Drive apartment. He drove away in his 2005 BMW and was stopped by officers minutes later. The high quality hydroponic marijuana, with a street value in excess of \$100,000, was bundled in separate large bricks.

In addition to the marijuana, detectives also seized the BMW and \$1,241 cash.

Alert police work by South Precinct Detective Jeff Polk, along with that of Canine Officer Jerry Denton and his partner Roscoe, led to the arrests of three individuals in connection with an apartment parking lot carjacking.

**Calvin Lee Guy** of Cedar Ash Crossing, **Dwight Jno Baptiste** of Hamilton Church Road, and **Jocquarius Tillmon** of Murfreesboro Pike, all age 18, are presently charged with vehicle theft and evading arrest. Additional charges are pending further investigation.

At 4:05 a.m., a 26-year-old man reported that he was standing outside of his Linbar Drive apartment building when three men approached (at least two of them armed with pistols) and robbed him of his car keys and other belongings. They used the keys to flee in the victim's girlfriend's 2007 maroon Kia Optima. The victim quickly called police and reported the vehicle description.

It wasn't long before Detective Polk spotted the Kia at a convenience market on Eagle View Boulevard in Antioch. Detective Polk and Officer Justin Pinkleton attempted to stop the vehicle, which ultimately crashed near the intersection of Hamilton Church Road and Pin Oak Drive. All the persons inside the Kia bailed out and ran. Officer Denton and Roscoe were called to help track the suspects and found Guy and Jno Baptiste in the 1100 block of Lakewalk Drive. They were taken into custody. Tillmon, in wet and muddy clothing, attempted to walk past the crash scene and was arrested. All three admitted to being in the Kia.

#### East

Two Nashville men are now charged for shooting William Edward Givens at N. 7<sup>th</sup> & Howerton Streets in East Nashville.

Cardell Woodard, 27, of N. 6<sup>th</sup> Street, and Aaron Ross, 30, of Stockell Street, are each charged with especially aggravated robbery.

Investigation by East Precinct Detective Curtis Hafley shows that Givens, 34, was seated inside an SUV when Woodard and Ross approached. Ross is alleged to have reached into the vehicle and struggled with Givens while trying to rob him. Givens forced the vehicle door open, sending Ross to the ground. Givens said that Ross and Woodard then shot him multiple times.

Givens was driven to General Hospital by a friend and was then transferred to Vanderbilt University Medical Center where he has undergone multiple surgeries to treat the gunshot wounds.

A violent Nashville criminal who was released from prison last month is now back behind bars on charges of carjacking and resisting police.

Christopher Maurice Lewis, 28, whose multi-year prison sentence expired on August 25<sup>th</sup>, is accused of confronting a 60-year-old East Nashville woman inside her car at 6:45 p.m. as she

prepared to leave the CVS Pharmacy at 2516 Gallatin Pike. The victim reported that a gunman pulled her from the 2002 Chevrolet Impala and drove off. She was not seriously hurt.

At 9:25 p.m., East Precinct undercover officers located the Impala backed into a parking lot near Dickerson Pike and Ewing Lane. A man matching the same description as the carjacker (Lewis) was seen behind the wheel. Officers moved in and took him into custody. A silver toy gun was recovered from the car. In a subsequent interview with Detective Paul Harris, Lewis admitted to the carjacking and said that he was looking for someone else to rob at the time of his arrest.

Records reflect that Lewis was convicted in July 2005 on four counts of facilitation of aggravated robbery for which he received four six-year sentences. He was also convicted on two counts of aggravated assault for which he received two four-year sentences.

Lewis is being held in the Metro Jail in lieu of \$160,000 bond.

#### **Madison**

Aaron Donte Evans Jr., 23, a convicted robber, and Prince Kennedy Jr., 25, are accused of robbing a man at gunpoint in the parking lot of Graycroft Apartments, 165 Starr Boulevard. They fled in a blue Dodge Charger. Witness information greatly assisted Canine Officer John Hutcheson, who spotted the suspect car on Old Hickory Boulevard. Evans and Kennedy were stopped and taken into custody. Two handguns were recovered from the Dodge Charger along with items stolen from the victim.

Evans and Kennedy are both charged with aggravated robbery. Evans was also booked on outstanding warrants related to the assault of his girlfriend. In 2008, Evans was sentenced to eight years for aggravated robbery and three years for aggravated assault. Kennedy has previous convictions for drug possession and theft.

A Greenbrier man's failure to renew the license plate on his Chevrolet S-10 pickup truck has landed him in jail on a felony charge of possessing more than six pounds of marijuana for resale.

Just after 9 p.m., Madison Precinct Flex Officer Ernie Jones saw the truck traveling on Myatt Drive and initiated a vehicle stop due to the expired tag. As Officer Jones approached the driver, Joseph Griffin, 36, the odor of marijuana was obvious. Located on the front seat, under a thick hooded sweatshirt, was a marijuana brick weighing 6.05 pounds worth an estimated \$27,000 on the street.

Griffin refused to answer any questions about the marijuana.

#### West

Quick, heads-up police work by West Precinct officers led to the arrest of two persons minutes after they allegedly robbed a woman in the parking lot of Centennial Sportsplex on 25<sup>th</sup> Avenue North.

Brandon L. Ashworth, 23, of Winn Avenue, and Belinda C. Frazier, 24, are both jailed on charges of aggravated robbery and evading arrest.

The 31-year-old victim pulled into the parking lot at 5:30 a.m., got out and went to the trunk of her car. A man got out of a green Honda Civic parked in the lot, came up from behind and demanded the victim's belongings. The victim also heard the slide action of a pistol as the robber approached and then saw the imprint of a gun through the suspect's shirt. She complied with his demands. The suspect, who was later positively identified as Ashworth, ran back to the Honda and left the scene.

The victim quickly called 911. Officers flooded the area and spotted the fleeing Honda, which ultimately crashed at the intersection of Morrow Road and Kentucky Avenue. Ashworth and Frazier ran a short distance before being apprehended.

Ashworth was convicted of facilitating especially aggravated robbery in 2007 and received an eight-year sentence. He was convicted of car burglary in January of this year and received a two-year sentence, which was suspended. Ashworth was on probation at the time of this morning's robbery.

Ashworth and Frazier are under investigation in connection with other criminal activity.

West Precinct Flex officers arrested two serial shoplifting suspects while working an antitheft undercover operation at Green Hills Mall.

Dominique Stone, 20, and Lamontiesha Johnson, 19, were observed by officers inside Gymboree putting merchandise into their purses. Once the women exited the store without paying for the items, officers attempted to stop them but they fled on foot to the parking lot.

Stone ran to her car. When officers approached the vehicle, Stone drove toward them. One officer had to move quickly out of the way to avoid being hit. Stone then stopped and was taken into custody without further incident. Recovered from the car was more than \$2,000 worth of merchandise taken from several stores inside the mall. Stone had previously been banned from Green Hills Mall for shoplifting.

Johnson, who was holding her young child, ran out in front of moving vehicles to avoid capture. She was taken into custody in the parking lot.

Stone and Johnson are each charged with felony theft and evading arrest. Additionally, Stone is charged with aggravated assault against a police officer, criminal trespass and driving on a revoked license.

Both women have previous theft convictions.

West Precinct Flex officers and Members of the U.S. Marshal's Fugitive Task Force arrested Jorge Flores who was wanted for two separate shooting incidents from last month.

On August 25<sup>th</sup> Flores allegedly shot a man outside a Rice Road apartment after the victim argued with a friend of Flores.

Flores is also accused of firing shots toward several persons on August 4<sup>th</sup> outside Club Cielo at 15115 Old Hickory Boulevard, striking one man in the hand and upper leg.

Neither victim's injuries were life threatening.

Flores was located at a home on Hillside Avenue and taken into custody without incident.

### **Central**

The continuing investigation into what detectives believe was the intentional killing of 2009 missing person Michael Wayne Parsley resulted in this week's indictment of Nashvillian Paul Lloyd Davis II on a charge of first-degree murder.

Ironically, Davis, 46, of Edmondson Pike, was arrested on Monday after Central Precinct Officer Charles Embry pulled him over for careless driving on 6<sup>th</sup> Avenue South at Peabody Street and found pills in the car for which Davis admitted he did not have a prescription. Davis' bond on the drug charge was set at \$75,000. He was still in jail when the Davidson County Grand Jury returned the murder indictment.

Human remains believed to be those of Parsley were recovered from a shallow grave in rural Wayne County last Friday. Investigation by Homicide-Cold Case Detective Steve Jolley alleges that Davis beat Parsley to death in April 2009 in a West Nashville alley. Detectives believe Davis then transported the body to rural Wayne County. Davis and Parsley were acquaintances.

Parsley's daughter reported him missing on April 20, 2009, after having last heard from him on April 10.

Davis' bond on the murder indictment has been set at \$250,000 by Criminal Court Judge Steve Dozier.

### **Specialized Investigations Division**

The continuing investigation into a numbers gambling operation allegedly run by Nashvillian Edna Davenport has now resulted in the seizure of an additional \$275,235 in cash from bank lockboxes.

Gambling Unit detectives assigned to the Specialized Investigations Division "froze" the lockboxes on September 6<sup>th</sup> as they executed search warrants at Davenport's Atomic Market on Buchanan Street and two residences. One of the lockboxes was forced open, revealing \$205,000 cash. The second was forced open on September 12<sup>th</sup> and was found to contain \$70,235 cash.

Including the \$160,000 seized September 6<sup>th</sup>, the \$275,235 from the lockboxes and money frozen in Davenport's bank accounts, the cash accounted for in this case now stands at \$519,000.

Detectives believe that Davenport, 60, of 2949 Mossdale Drive in Antioch, has, for a lengthy period of time, operated an illegal numbers gambling venture which featured the Atomic Market as the hub. A home at 2403 Osage Street was the alleged "count house" for the gambling proceeds.

Davenport is charged with aggravated gambling promotion, a felony, and possession of gambling records.

Illegal numbers gambling involves wagering on a daily widely publicized number, such as the close of the New York Stock Exchange.

Davenport was convicted of gambling promotion in 2008 and 2011.



Narcotics detectives from the Specialized Investigations Division on September 18<sup>th</sup> culminated a month-long investigation into cocaine sales at Daniela's Bar at 12 E. Thompson Lane with a search of the business and the arrest of the case's primary target.

Francisco Gaytan, 45, is jailed tonight on five counts of selling cocaine. He is alleged to have sold cocaine to a police operative inside the bar on four occasions. The fifth count involved an alleged sale from Gaytan's home at 2920-B Glencliff Road. Gaytan, who was convicted of a felony marijuana charge in 2005, is being held in lieu of \$75,000 bond.

Assisting in the investigation were members of the Crime Suppression Units from the South and East Precincts. The Metro Health Department and the Tennessee Alcoholic Beverage Commission took part in the search warrant execution at the bar.

#### 2013 Metro Employees' Seasonal Flu Shot Clinics

The Metro Public Health Department will offer seasonal flu shots free for current Metro Nashville Government employees who want the best protection against seasonal influenza.
