I am pleased to report that Officer John Downs is continuing to improve from the gunshot wound he suffered on December 14th. He is now attending physical therapy three days a week and is able to get around with the use of crutches. Officer Downs has a tremendous attitude and is looking forward to a full recovery, although he still has a ways to go. Officer Downs wrote this open letter to his police department colleagues to express his personal thanks for all of the support:

Again, I thank you all, for your assistance and the outpouring of help to me and my family, and especially the multitude of prayers.

Christmas Basket Program

More than 180 needy Nashville families including 577 children and 60 elderly persons received gifts of food and toys from Metro police officers Christmas Eve morning as the police department's annual Christmas Basket Program celebrated its 53nd anniversary.

In its inception, the program served two families. Over the years, requests for assistance and those actually helped by the program have steadily grown. Families are chosen at the recommendation of police officers who come into contact with them during the year.

Contributions from police department personnel, both sworn and civilian, and the Nashville community fund the program. The Music City and Rivergate Chapters of the Harley Owners Group have partnered with the program for a number of years and are significant contributors of their time and resources.

"Former Chief Joe Casey, who began this program in 1961, knew that the police department's mission was to make a positive difference in the lives of Nashville's families, especially the disadvantaged," Chief Steve Anderson said. "That sentiment continues, and I am very proud of our employees and community partners for their commitment to this tradition of caring."

Precinct News

West

SWAT officers assigned to the Special Response Team arrested armed fugitive and accused murderer Hassan Al Mutory in the driveway of a home in the 400 block of Ewing Drive.

Al Mutory, 19, had been a fugitive since last September 1st, when West Precinct detectives swore out an arrest warrant charging him with the fatal shooting of Carlos Gomez, 20, in the front yard of 477 Summit Oaks Drive in Bellevue. The August 31st shooting took place in the midst of an altercation that had erupted during a party at the residence.


Members of the Special Response Team, following up on information developed by West Precinct detectives, located Al Mutory in the driveway of 469 Ewing Drive. He rammed an unmarked police vehicle with his Dodge Magnum in an attempt to escape, but quickly surrendered when he discovered that he would not be able to get away. Al Mutory was armed with two pistols and possessed quantities of marijuana, cocaine, Oxycodone pills and nearly \$2,500 cash.

Madison

Hermitage

Convicted burglar Shawn Tate, 26, is back behind bars charged with one home burglary and suspected in at least eight others in Hermitage.

A woman called police to report that a man was burglarizing her Highland View Court residence. Prior to breaking a window to make entry, Tate allegedly cut power to the house by turning the exterior breaker off. There have been similar break-ins reported in nearby neighborhoods.

Tate, of Hickory Hills Lane, was released from prison in December 2014 after serving eight years for two Hermitage home break-ins.

An investigation into the delivery of a package to an East Nashville residence resulted in the arrest of Lacey Saborido, 30, and the seizure of more than three pounds of marijuana and a handgun.

Hermitage Precinct's Crime Suppression Unit executed a search warrant at Saborido's residence at 1218B Stockell Street after she took the package inside. Detectives opened the

package and recovered 3.2 pounds of marijuana. An additional three ounces of marijuana, a revolver, and digital scales were found inside the residence.

Saborido admitted that she had the marijuana shipped to her residence. She is charged with marijuana possession in a drug-free school zone and possession of a firearm in the commission of a felony. Saborido is being held in lieu of \$130,000 bond.

North

Kendrius Smith, 18, was arrested a short time after he allegedly robbed a woman while she was walking with a friend on 5th Avenue North at Taylor Street.

The victim reported that the suspect approached her just before 10 p.m., indicated that he had a weapon, and took her purse. He pushed her down before fleeing on foot. About 30 minutes later, officers spotted Smith, who matched the suspect description, walking on 4th Avenue North near Buchanan Street. They took him into custody. The victim positively identified Smith as the person who robbed her.

Smith, of Hume Street, is charged with aggravated robbery and assault. He is being held in lieu of \$75,000 bond.

Central

Investigation following a vehicle stop led to the arrest of a man and woman who are charged with manufacturing methamphetamine after the makings of a mobile meth lab were found inside the car.

Central Precinct Officer Matthew Bajt stopped a car on Demonbreun Street after the driver, Mark J. Robertson, 45, ran a red light at the intersection of 6th Avenue South and Demonbreun Street at 4 a.m. Robertson did not have any identification. He and his passenger, Vanity Mistich, 23, appeared nervous. When Robertson stepped out of the car, Officer Bajt saw a bag of needles in plain view on the door handle. During a subsequent consent search of the vehicle, Officer Bajt discovered a backpack that contained what appeared to be items commonly used to manufacture meth, glass jars that contained a white rocky residue, a digital scale, and additional needles.

Robertson, of Carthage, Tennessee, and Mistich, of Nashville, are both charged with manufacturing methamphetamine.

Proactive police work led to the arrest of murder suspect Aaron Dale Dodson, 22, who was wanted for the September 21st fatal shooting of Ricky Burgett Jr. during a robbery inside Burgett's Welshwood Drive apartment.

Central Precinct Officer Jason King stopped the driver of a vehicle with an expired tag on South 1st Street near Woodland Street. During further investigation, the front seat passenger was identified as Dodson, who initially gave Officer King a false name.

Dodson, of Oak Court, is now charged with criminal homicide and is being held in lieu of \$540,000 bond.

At the time of Burgett's murder, Dodson was free on bond on charges of aggravated robbery and aggravated burglary stemming from a January arrest. In that case, Dodson is alleged to have confronted a woman at gunpoint on the front porch of her Oak Court home before ordering her inside, robbing her and burglarizing the residence.

Dodson's co-defendant, Oral Patterson, 19, was arrested in October.

Midtown Hills

A tip to Nashville Crime Stoppers led to the arrest of murder suspect Tadarius Clift at a Clarksville Pike drugstore.

Clift, 18, is under indictment for the shooting death last September 23rd of Nathaniel Moore on Edgehill Avenue.

South

South Precinct detectives arrested a 24-year-old convicted robber for last July's murder of 18-year-old Deshaun Sawyers at the Exxon Tiger Market at 340 Harding Place.

Corey Marchbanks was taken into custody at his girlfriend's home on Strouse Avenue by SWAT officers assigned to the Special Response Team. He is named in a grand jury indictment charging first-degree murder. Marchbanks' co-defendant, Derrick L. Lyons Jr., 22, of Buenaview Court, who is also charged with first-degree murder, was served with the indictment after being returned to Nashville from Murfreesboro where he was in jail on unrelated charges.

On the night of July 14th, Deshaun Sawyers and four friends were heading from Murfreesboro to a party in Brentwood when Sawyers told the driver that he needed to meet someone at the Exxon. Sawyers got out of the car, walked to the side of the building and got into an SUV. Witnesses immediately heard gunshots and the victim ran from the SUV and collapsed in front of the store. He was transported to a local hospital where he died.

Investigation by Detective Danny Warren and his colleagues at the South Precinct led to the identification of Marchbanks and Lyons as the persons involved in this drug-related homicide.

A citizen's tip led to the arrest of three persons involved in five South Nashville home burglaries.

Officers' quick response to a break-in on LuAnn Drive led to the arrest of the alleged getaway driver, Karlton Braden, 20, of Calais Circle. During the continuing investigation, two other suspects were identified, Zakaria Chanaoui, 20, of Islandia E, and a 17-year-old. All three confessed to their involvement in the Luann Drive burglary and to a second break-in at a residence on Calumet Drive.

Additionally, Chanaoui and the 17-year-old admitted to burglarizing a Calais Circle home and two residences on Clearlake Drive E & Wood Bridge Drive.

Chanaoui is charged with five counts of aggravated burglary. He is being held on \$125,000 bond. Braden is charged with two counts of aggravated burglary and is being held in lieu of \$50,000 bond.

The teen is charged in Juvenile Court with five counts of aggravated burglary.

A blood drive at the South Precinct resulted in the donation of 23 units of lifesaving blood.

Specialized Investigations Division

Two convicted felons serving their sentences on supervised release are back behind bars after narcotics detectives assigned to the Specialized Investigations Division discovered 2.5 pounds of marijuana, some of it bagged for distribution, and 6 firearms inside their 1904 Westchester Drive residence in Madison.

During the execution of a search warrant, detectives seized the marijuana, four pistols located in a suitcase sitting on a bed, and two assault-type rifles.

Diondra S. Holland, 29, who received an eight-year probated sentence last October for 2nd degree murder, and Leviticus Holloway, 27, who received an eight-year community corrections sentence last February for a felony cocaine conviction, are now charged with possessing marijuana for resale, gun possession in the commission of a drug felony and possession of drug paraphernalia. They also face warrants accusing them of violating their supervised release conditions



Specialized Investigations Division narcotics detectives have made another dent in Nashville's heroin trade with the arrest of two deliverymen who were working for a Mexican-based distribution organization.

Roberto Bogarin-Ramirez, 20, and Edgar Haller-Bogann, 25, are charged with multiple counts of selling heroin, engaging in a heroin conspiracy and possession of heroin for resale. They are jailed in lieu of \$675,000 bond each.


The investigation that led to the arrests and the seizure of more than one pound of heroin began in November. Heroin dispatchers in Mexico with Nashville area telephone numbers took orders from buyers and arranged for deliverymen to meet customers in the restrooms of various businesses, including home improvement stores, grocery stores and large variety stores, primarily in the Hermitage area.

Detectives followed Bogarin-Ramirez and Haller-Bogann, who have sold heroin to undercover officers on numerous occasions, as they entered a grocery store on McGavock Pike and headed to the restroom. Both were taken into custody and later acknowledged the connection of Mexican drug organizations to Nashville's heroin trade.

The investigation also led to the execution of a search warrant at an apartment in the Bavaria complex on Packard Drive. Detectives seized more than one pound of heroin (valued in excess of \$50,000), \$2,500 cash, packaging materials and tools. In addition, they found evidence showing how the two would wire the proceeds of drug sales to individuals in Mexico.

Also arrested was Sevron Shelton, 37, of Richards Road, who was seen leaving the grocery store after purchasing heroin from the two sellers. Shelton was stopped and admitted to swallowing one gram of heroin when officers approached him. Shelton was transported to Southern Hills Medical Center for his safety. Staff there retrieved the heroin without complication. Shelton is charged with heroin possession and evidence tampering.

Heroin interdiction remains a priority for the Specialized Investigations Division due to the real potential for serious health issues and even death to those who inject it into their bodies.






The continuing effort by narcotics detectives to identify and arrest heroin distributors in the Nashville area led to the arrests of two South Nashville men.

Edgar Cisneros-Carmona, 26, of 3817 Faulkner Drive, and Victorio Mendoz-Espinoza, 27, of 4501 Packard Drive, are jailed on charges that they dealt heroin to buyers who would meet them in various South Nashville parking lots. It is believed that customers would telephone a dispatcher, suspected of being in Mexico, who would then relay the order to Cisneros-Carmona and/or Mendoz-Espinoza in Nashville.

At the culmination of this investigation, detectives seized more than a half pound of heroin, 1 rifle, 4 pistols, \$6,639 cash and 4 vehicles.

The two defendants are each jailed on bonds of more than \$400,000.



Seized guns & heroin

Narcotics detectives assigned to the Specialized Investigations Division charged a Los Angeles man with flying into Nashville with more than 900 Oxymorphone pills concealed in a vitamin jar inside his checked luggage.

Marques Edwards, 28, is jailed in lieu of \$360,000 bond on charges of possessing the powerful painkillers for resale and evading arrest.

Nashville International Airport Police and DEA agents were alerted to a suspicious piece of checked luggage. A drug dog sniffed the bag and alerted to the presence of narcotic odor. After Edwards claimed the bag, law enforcement officers approached, identified themselves and asked for permission to search the luggage. Edwards attempted to flee the airport terminal, but was ultimately stopped. A check of the luggage pursuant to a search warrant revealed the pills, which carry a street value of approximately \$75,000.



A Virginia man's maneuver to avoid passing by a Metro police officer on I-40 this morning only drew attention to his Ford Mustang and wound up landing him in the Metro Jail on felony marijuana and weapon charges.

Christopher Cameron, 20, of Bumpass, Virginia, was traveling east on I-40 when he got off the interstate at the McCrory Lane exit and immediately got back on. In doing so, Cameron avoided driving by Interdiction Officer Robert McIsaac who was parked on the shoulder of I-40. McIsaac took note of Cameron's 2004 silver Mustang and stopped it for speeding a few miles away. Cameron appeared nervous, said he was traveling from Texas, but could not say where in Texas. When Cameron declined a request to search the Mustang for narcotics, Officer McIsaac's police dog partner, Paco, checked the car and strongly alerted to the trunk. Inside were 1.5 pounds of high-grade marijuana, marijuana wax, drug paraphernalia, an AR-15 rifle and ammunition.

Cameron is charged with possessing marijuana for resale, gun possession in the commission of a felony drug crime, and unlawful use of drug paraphernalia. His bond is set at \$305,000.



Seized marijuana and weapons

Vice detectives from the Specialized Investigations Division executed search warrants at three Nashville massage spas after undercover operations showed employees at the businesses were engaging in acts of prostitution. The investigations began after community complaints.

The three establishments involved are:

- AAC Massage, 4243 Lebanon Pike, Suite B
- Hickory Day Spa, 5722 Hickory Plaza Drive, Suite A1
- What A Day Spa, 1463 Bell Road

Operatives working on behalf of the police department entered the businesses on several occasions in January. Female employees of AAC Massage are alleged to have engaged in sexual contact with operatives on three occasions. Female employees of Hickory Day Spa are alleged to have engaged in sexual contact with operatives on two occasions, the same for female employees of What A Day Spa.

Eight women who work at the businesses, all natives of China, today were issued misdemeanor prostitution citations. They are identified as:
