## Carriage Driver Permit Process

**New Drivers:** In order to obtain a carriage driver permit, the following actions must be taken:

- Complete a yellow carriage driver application.
- Undergo an FBI fingerprint-based identification/criminal background check.
- Undergo a D.O.T. physical from a qualified doctor or medical facility. Submit the signed Medical Examiner's Certificate to this office.
- Undergo a D.O.T. drug test from a qualified doctor or medical facility, with results to be faxed to this office (**not** older than 30 days).
- Obtain a valid Tennessee driver's license with an "F" endorsement (Endorsements A, B, C or CDL are also acceptable).
- Obtain a Motor Vehicle Report (MVR) from the Tennessee Department of Safety (not older than 30 days).
- Submit two color passport size photographs.
- Provide proof of U.S. citizenship or appropriate ICE documentation.

**Renewing Drivers:** In order to renew a carriage driver permit, the following actions must be taken:

- Complete a yellow carriage driver application.
- (If last fingerprint-based background check was more than 5 years ago) Undergo a FBI fingerprint-based identification/criminal background check.
- (If D.O.T. Medical Card has expired) Undergo a D.O.T. physical from a qualified doctor or medical facility. Submit the signed Medical Examiner's Certificate to this office. Also, Undergo a D.O.T. drug test from a qualified doctor or medical facility, with the results to be faxed to this office.
- Produce a valid Tennessee driver's license with an "F" endorsement (Endorsements A, B, C or CDL are also acceptable).
- Obtain a Motor Vehicle Report (MVR) from the Tennessee Department of Safety (not older than 30 days).
- Submit two color passport size photographs.
